
**CIRCULAR:-**

A reference is invited to this vide this office Circular No.UG/84 of 2013-14, dated 27<sup>th</sup> December, 2013 to amendment in Regulation 8721 regarding fee structure of Bachelor of the Arts (Film, Television & New Media Production) and the Principals of affiliated Colleges in Arts are hereby informed that the recommendation made by Board of Studies in Mass Media at its meeting held on 12<sup>th</sup> August, 2016 has been accepted by the Academic Council at its meeting held on 30<sup>th</sup> September, 2016 vide item No. 4.11 and that in accordance therewith, the Fee Structure as per the Choice Based Grading System for the Arts (Film, Television & New Media Production), which is available on the University's web site ([www.mu.ac.in](http://www.mu.ac.in)) and that the same has been brought into force with effect from the academic year 2016-17 as follows :-

- A) Admission fees Rs.1000/- (Shall be taken in only at Sem. I, III & IV)
- B) Tuition fees Rs.16000/- (Shall be taken in every Semester)
- C) Library fees Rs.1000/- (Shall be taken in every Semester)
- D) Computer Lab fees Rs.6000/- (Shall be taken in every Semester)

The same is available on the University's web site ([www.mu.ac.in](http://www.mu.ac.in)) and that the same has been brought into force with effect from the academic year 2016-17.



Amendment in Regulation 8721 Fee Structure of Bachelor of Arts (Film, Television and New Media Production).

The board has discussed the Amendment in Regulation 8721 Fee Structure of Bachelor of Arts (Film, Television and New Media production) and has been resolved that the course fee is as follows:

Admission fees Rs. 1000/- (Shall be taken in only Semester – I, III & IV)

Tuition fees Rs. 16000/- (Shall be taken in every Semester)

Library fees Rs. 1000/- (Shall be taken in every Semester)

Computer Lab fees Rs. 6000/- (Shall be taken in every Semester)

An Additional Refundable Security deposit of Rs. 10,000/- (At the time of admission to First Year) will be charged to the students and will be refunded to them post the completion of the course provided there is no loss to either equipments & library material.
