



ORDINANCES AND REGULATIONS OF THE B.B.A.-LL.B.(HONS.)
PROGRAMME

- O.....: Admission to the First Year (First and Second Semesters) of B.B.A.- LL.B. (HONS.) Degree Programme shall be granted as per the procedure as shall be laid down by the University from time to time, provided the student has passed/completed H.S.C. examination in any Faculty of a recognised Board or equivalent qualification with minimum 45% of marks at the qualifying examination. However the above percentage of Marks shall be relaxed by 5% for the students belonging to SC/ST categories, or such other qualifications as shall be prescribed by the University or the Government or any other competent authority having powers to do so.
- R: The B.B.A.-LL.B (HONS.) programme leading to B.B.A.- LL.B. (HONS.) Degree in Law shall be Ten Semesters Full-time Course, or as shall be amended by the University of Mumbai of its own or as per the suggestions / directions from the competent authorities from time to time.
- R.....: The student migrating from the other Indian Universities to the University of Mumbai seeking admission or 3rd and 4th, 5th and 6th, 7th and 8th or 9th and 10th Semesters of B.B.A.- LL.B. (HONS.) programme, on comparing the syllabi in the subjects of his previous University and of this programme, such student may be required by way of condition to pass in the examinations of this University in such subjects/courses of the lower semesters of B.B.A.-LL.B. (HONS.) which he has not passed in the lower classes in the previous University; and also that he may be exempted from appearing at the examinations in such subjects/courses of the higher semesters of this programme which he had already passed in his previous University.
- R: Student may be admitted to both the semesters of this programme in every academic year at the beginning of the Academic Year.
- R: The total intake per batch per College shall be as per the rules prescribed from time to time by the University.
- R: No student will be admitted to the Semester Examination unless he has completed requisite attendance in the given semester as per the University Rules and Regulations; and if any of the student fails to keep the requisite

attendance, he shall be allowed to appear at the said semester examination in the subsequent academic year on his attending requisite number of lectures of the said semester in the subsequent academic year by paying the fees for the said semester as shall be decided by the University from time to time; but the marks the student had already obtained in the internal component of that semester and the corresponding credits shall be carried forward for the said semester in the subsequent semester.

R: Performance of the students shall be evaluated as per the examination pattern and by further rules and procedures as shall be decided by the University from time to time. The students performance in the Clinical Legal Education subjects/courses shall also be evaluated as per the guidelines issued by the University from time to time.

R: For the examinations in all the courses/subjects, except in the subjects/courses in Clinical Legal Education shall be conducted in the following manner:

- a) Except in the subjects/courses of Clinical Legal Education, the Theory Examination of the External Component (Semester End Examination) shall be of 75 Marks in every subject/course, and the Internal Component Evaluation (Continuous Assessment/Evaluation) shall be of 25 Marks as per the scheme and rules as shall be decided by the University from time to time
- b) Theory Examination of the External Component of 75 Marks for first Four Semesters (i.e. Semester I, II, III and IV) in every subject/course shall be conducted by the respective College / Institution / Department / Centre etc., and result shall be finalised, declared and issued by the respective College / Institution / Department / Centre etc.; and those for the later Six Semesters (i.e. Semesters V, VI, VII, VIII, IX and X) in every subject, except of Clinical Legal Education, shall be conducted by the University.
- c) Internal Component Evaluation (Continuous Assessment/Evaluation) of 25 Marks as per the scheme and rules as shall be decided by the University from time to time in every subject/course shall be conducted by the respective College/Institution/Department/Centre etc. where the student is admitted.

- d) For the sake of clarity it is mentioned that the examination/s and its evaluation in the subjects/courses of Clinical Legal Education shall be held and conducted by the concerned Institution to which the student is admitted, and the marks of Internal Component Evaluation (Continuous Assessment/Evaluation) as well as Clinical Legal Education examination shall be sent to the university before commencement of the examinations of the respective semester and the same shall be accepted by the Examination Section of the University and shall be included in the marks-statements to be issued by the University to the students alongwith the marks obtained at the Semester End Examinations.
- e) All the results declared till now by the Thane Sub Campus School of Law shall be verified by the university and after verification new marksheet shall be by the university with 7 pointers instead of 10 pointer which was by Thane Sub Campus School of Law earlier.
- f) The results of the students admitted to the said programme in the first year of the programme till 2014-15 and 2015-16 shall be declared on 7 points grade system as follows:

All the courses in this programme shall be of four credits each.

g) The results of the students admitted to the said programme in the first year of the programme from 2016-17 shall be declared on 10 points grade system as follows:

All the courses in this programme shall be of four credits each.

- R: A student shall be declared "Passed" in the subject/course if he has secured 2014 minimum 50 marks out the total of 100 marks assigned to every subject/course with minimum 50% marks in Internal Component and Semester End Examination. If the student fails to secured minimum 50 marks then they have to reappear for the examination/examination in the said subjects/courses; however at their option they may not appear at the internal / external components of the examination in the said subjects/courses in which they have secured minimum 50% of the marks of that component.
- R: A student shall be declared "Passed" in the Semester Examination if he has passed in all the subjects/courses of that Semester as per the provisions mentioned in the preceding rules.
- R: If a student fails to "Pass" in all the subjects/courses of both the semesters of a particular Academic Year, he will be allowed to keep term of the next consecutive two semesters (i.e. next academic year) if he has passed in any of

the 8 subjects/courses together of both the semesters of the respective academic year.

R: The student will be allowed to take admission to the next class (to both the semesters of the next academic year) of the programme, if he has passed in all the subjects/courses of the previous semesters; OR if he has passed in all the subjects/courses of the semesters of the year/s previous to the year which the student attended last and any eight subjects/courses taken together of both the semesters last attended; i.e. Admissions to the higher semesters of the next Academic Year of the Course shall be granted as follows:

- a) For admission to the Semesters 5th and 6th the student must have passed in all the subjects/courses of Semesters 1 and 2 and also 8 subjects/courses of Semesters 3 and 4 taken together.
- b) For admission to the Semesters 7th and 8th the student must have passed in all the subjects/courses of Semesters 1 to 4 and also 8 subjects/courses of Semesters 5 and 6 taken together.
- c) For admission to the Semesters 9th and 10th the student must have passed in all the subjects/courses of Semester 1 to 6 and also 8 subjects/courses of Semesters 7 and 8 taken together.

R: The results of the student appearing at the 4th, 6th, 8th or 10th Semester of 5 years B.B.A. - LL.B. (HONS.) Course shall not be declared unless and until the student has been declared Passed in all the subjects/courses up to 2nd, 4th, 6th or 8th Semester respectively.

R: The syllabi of the various subjects/courses shall be as approved and passed by the University Authorities.

O: The B.B.A.-LL.B (Hons.) Degree in Law is an integrated degree and shall be conferred on the students on successful completion of the five years programme by passing in or clearing all the papers/courses prescribed for each and all the Semester Examinations of the programme in accordance with the provisions relating to each Semester examination, unless the student has been exempted from appearing at the examinations in some of the subjects/course of this University in accordance with the provisions of prevailing Rules and Regulations.
