> Sub. :<u>Election to the Senate from the Representative of the</u> <u>Management of the Affiliated Colleges/Autonomous</u> <u>Colleges/Conducted Colleges/Recognized Institutions</u> <u>Under Section 28 (2) (p) of the Maharashtra Public</u> <u>Universities Act, 2016:</u> <u>Preparation of Electoral Roll thereof.</u>

Mesdames/Gentlemen,

I am to invite your kind attention to Section 62 of the Maharashtra Public Universities Act, 2016 regarding the term of office of members of authorities of the University which provides that the term of every authority constituted under this Act shall commence on the  $1^{st}$  September and shall be of five years from the said date and the term of members of every authority shall expire on the expiry of the said period of five years irrespective of the date on which a member has entered upon his office. The process of election, nomination and co-option shall be commenced at least three months before expiry of the term of the authority and shall be completed not later that  $30^{th}$  November in that year.

I am to invite your kind attention to Section 28 of the Maharashtra Public Universities Act, 2016 regarding the Senate. Section 28(1) of the Act provides that the Senate shall be the principal authority for all financial estimate and budgetary appropriations and for providing social feedback to the University on current and future academic programmes. Section 28(2) of the Act, provides for composition of the Senate whereas Section 28(2)(p) of the Act, provides for election to the Senate from the representative of management of the Affiliated Colleges, Autonomous Colleges, Conducted Colleges and Recognized Institutions.

The Government of Maharashtra Order No. 1 th. & 2016@i tdt347@fof' & 3 dated 18<sup>th</sup> May, 2017 has introduced new statute in the Maharashtra Public Universities Act, 2016. Further, the Government of Maharashtra Gazette dated 29<sup>th</sup> April, 2017, has introduced the eligibility conditions for getting elected as member of various authorities/bodies.

## :: 2 ::

The University is therefore inviting all the approved representative of managements to register themselves with the University. The representative of managements can enroll themselves for appearance of their name on the Electoral Roll is as per the procedure laid down by the University. The registration shall start from the date of this notification i.e. 5<sup>th</sup> June, 2017 and ends on 4<sup>th</sup> July, 2017 by 4 p.m.

I am, therefore, to request you to kindly arrange to furnish the required information on Colleges/Institute letter head in the enclosed preformed in respect of the representative of management of your college/institution, addressed to the Deputy Registrar, Election Section, Room No. 110, First Floor, University Main Building, University of Mumbai, Fort, Mumbai – 400 032, so as to reach him on or before **4<sup>th</sup> July, 2017 up to 4.00 pm** for preparation of the Electoral Roll of the Representatives of Management of the Affiliated Colleges/Autonomous Colleges/Recognized institutions for the purpose of holding the aforesaid elections.

(16) Collegium of Management Representative means an electoral colleges consisting of representative of management committees of affiliated or autonomous colleges or institutions who shall elect from amongst themselves as member to the different authorities.

(37) Management means the trustees or the managing or governing body, by whatever name called, of any trust registered under the Maharashtra Public Trusts Act, or any society registered under the societies Registration Act, 1860 or a Company registered under section 8 of the Companies Act 2013, under the management of which one or more colleges or recognized institutions or other institutions of higher learning, are conducted and admitted to the privileges of the university.
