Act No. VI of 2017) the amendment of O.5608 relating to the eligibility criteria of Part-time Diploma Course in Foundations of Yoga has been brought into force with effect from the academic year **2018-19**, accordingly. **Amendment of O.5608 relating to the eligibility criteria of Part-Time Diploma Course in Foundations of Yoga :-**

Existing eligibility criteria	Amended eligibility criteria
A candidate for being eligible for admission to the course for the course in Diploma in Foundations of Yoga must have passed matriculation (Std. X) of the Maharashtra State Board of Secondary Education, Pune, or any other equivalent examination recognized by this University.	A candidate for being eligible for admission to Diploma in Foundations of Yoga must have passed SSC and HSC of the Maharashtra State Board of Higher Secondary Education, or any other equivalent examinations.

**Part-time Diploma Course in Foundations of Yoga.**

**Existing O. 5608 Eligibility:**

A candidate for being eligible for admission to the course for the course in Diploma in Foundations of Yoga must have passed matriculation, (Std. X) of the Maharashtra State Board of Secondary Education, Pune, or any other equivalent examination recognized by this University.

**Amended O.5608 Eligibility:**

A candidate for being eligible for admission to the course for the course in Diploma in Foundations of Yoga must have passed matriculation, (Std. XII) of the Maharashtra State Board of Higher Secondary Education, Pune, or any other equivalent examination recognized by this University.
