

## Round Table on Law, Literature and the Diaspora

The disciplines of Law and Literature in recent years have become triangulated with Diaspora Studies as texts on global migration and dispersion find echoes in national and international laws on migration and citizenship. Diasporic Literature looks towards legal studies as it seeks to portray the trajectories of migrants who legally and sometimes outside the ambit of the law make their homes in new lands. There are also Transnationals who are employed for short durations of time on work permits which are issued according to the laws of the country that has employed them. Such intermeshing of these three areas has led to the creation of interdisciplinary collaborative centres of study.

The University of Muenster, Germany has one such collaborative centre for the study of law and literature. As a partner of the University of Mumbai, the University of Muenster is looking at ways in which Mumbai University could participate in this venture.

This Round Table on Law, Literature and Diaspora is an attempt in this direction and would be brainstorming for ideas on the formalization of areas of overlaps and new fields for research. The Constructions of Home and Belonging Indian Diaspora Centre (CoHaB IDC), University of Mumbai has collaborated with Muenster in the area of Diasporic research and training under the European Union Marie Curie programme. CoHaB IDC looks forward to the deliberations of this Round Table leading to newer, interdisciplinary collaborations with the WWU and their Centre for Law and Literature.
