Kindly refer to this office letter dated 17.04.2025. By the said letter the General Directions given by the Hon'ble Chancellor have been circulated.

At point no.31 of the said letter the Hon'ble Chancellor has directed that the Universities must work on to increase the student enrolment for the UG & PG courses. The university shall also work on women empowerment, research in field of women safety, gender budgeting. The university shall also help & guide the women self-groups through the student volunteers.
