A reference is invited to the Ordinances and Regulations relating to the Under Graduate and Post Graduate programmes vide this office Circular Nos.UG/61 of 2013-14, dated 26th September 2013 and UG/04-A of 2014 dated 23rd June, 2014 the Directors/Heads of the University Departments the Principals of the affiliated Colleges, the Heads of the Recognized Institutions concerned are hereby informed that the recommendation made by the Faculty of Science has been accepted by the Academic Council at its meeting held on 29th May, 2015 vide item No. 4.11 and and subsequently approved by the Management Council at its meeting held on 27th June, 2015 vide item No. 5 and that in accordance therewith, in exercise of the powers conferred upon Management Council under Section 55 (1) of the Maharashtra Universities Act, 1994, Regulation 8435 & 8668 regarding the scaling down the marks ,which is available on the University's web site (www.mu.ac.in) and that the same has been brought into force with effect from the academic year 2015-16.

R. 8668 : Scaling Down the Marks Obtained by the Learner at the Internal Examination as Compared to the Marks Obtained by the Learner in the Semester End Theory Examination in the Course Concerned has been amended and now it shall be Read as follows :-

- a) Scaling down will not be applicable for all Semester and all programs (aided and unaided) of Under Graduates for CBSGS under the faculty of Arts, Commerce and Science with effect from 2015-16.
- b) It will continue to be applicable for all Semester and all programs (aided and unaided) of Post Graduates for CBSGS under the faculty of Arts, Commerce and Science with effect from 2015-16.

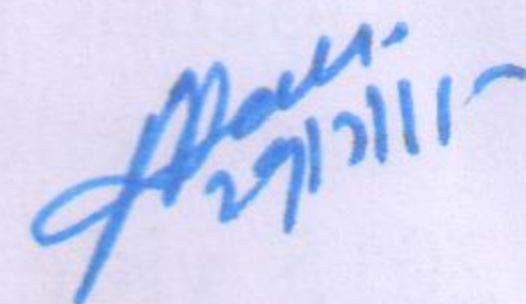
