Phil degree course and the Fee Structure for the Ph.D. (Arts) degree course under the faculty of Arts is as under and the same has been brought into force with effect from the academic year 2010-2011.

Further to that the State Government reservation policy and relaxation of percentage for reserved category shall be followed.
