- d) The college has adequate infrastructure facilities to accommodate additional students.
- e) The college has not been punished for any default in past three years.
- f) The College has sufficient infrastructure and approved faculty as per enclosed proforma.
- g) The college should have undergone the process of Assessment and Accreditation by NAAC, Bangalore, or it should have at least sent LOI.
- 2) The college will strictly adhere to the State Government reservation policy applicable for admission purpose
- 3) If the college requested less number of students to increase than the decision taken by the Committee, actual number of seats requested for shall be granted.
- 4) The last date of admission should be follow as per University Circular issued time to time but not later than 31st August, 2016."

Those who have already applied for the purpose, need not to be apply again. However, they have to fulfilled the above said conditions.

They are further informed that, the applications received on or before 22nd July, 2016 will only be considered.
