I to Sem. VI) in Landscape.

They are hereby informed that the recommendations made by the Ad-hoc Board of Studies in Architecture at its meeting held on 18th July, 2019, have been accepted by the Academic Council at its meeting held on 26th July, 2019 (vide item No. 4.52) and subsequently approved by the Management Council at its meeting held on 13th September, 2019 (vide item No.16) and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 74(4) of the Maharashtra Public Universities Act, 2016 (Mah. Act No. VI of 2017) and the Standard of Passing of the sixth semester examination of Three Year (Part time) Master of Architecture degree in Landscape as the said course was approved in the 2008 but course was actually started in 2016 and the standard of passing was remained to be included in the respective Regulation No. 5861-A (The same is available on the University's website www.mu.ac.in).

It may be Regulation read as:

R. 5861-A To pass the examination, the candidate must obtain 50% of the full marks in the sessional and 50% of the full marks in jury /external examination.

To be eligible for the final jury, the Candidate must have obtained 50% of the full marks in the sessional.

Those successful candidates who have obtained 55% of the total marks obtainable in the examination taken at one sitting only will be placed in Second Class.

Those successful candidates who have obtained 60% of the total marks obtainable in the examination taken at one sitting only will be placed in First Class.
