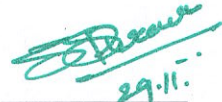

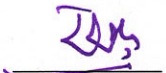

Memorandum of Understanding between Mumbai School of Economics and Public Policy (Autonomous) (MSEPP), The University of Mumbai, 3rdFloor, Ranade Bhavan, Kalina Campus, CST Road, Vidyanagari, Mumbai 400098 and Insurance Institute of India, C-46, G - Block, Bandra – Kurla Complex, Mumbai 400051 for an academic collaboration for the purpose of offering training courses/programmes in insurance and related subjects

This Memorandum of Understanding (MoU) is made this ____ day of Jan 2021 between the Mumbai School of Economics and Public Policy (Autonomous) (henceforth referred to as MSEPP), University of Mumbai, an autonomous Department constituted under the provisions of Section 52 (2) of the Maharashtra Public University Act, 1994 (Maharashtra XXXV of 1994), as

amended by Maharashtra Universities (Amendment and Continuation Act, 2000) having its administrative office on 3rd Floor, Ranade Bhavan, Kalina Campus, CST Road, Vidyanagari, Mumbai 400098, Maharashtra (hereinafter referred to as MSEPP which expression shall include its successors and assigns) of the ONE PART, and

Insurance Institute of India, a society registered under the provisions of Societies Registration Act, 1860 under No. BOM/129-74 GBBSD on 23-04-1974 having its registered office at C-46, G - Block, Bandra – Kurla Complex, Mumbai 400051, Maharashtra (hereinafter referred to as the said Insurance Institute of India which expression shall include its successors and permitted assigns), as the SECOND PART.

PREAMBLE

WHEREAS MSEPP is an autonomous Department of the University of Mumbai. It is one of the oldest Economics teaching departments with a rich legacy of towering personalities like Prof. C.N. Vakil; Prof. D.T. Lakdawala and Prof. P.R. Brahmanada to name only a few. The Department was granted academic autonomy by the University in 2006. In 2017, the Department of Economics was rechristened as Mumbai School of Economics and Public Policy and was re-structured so as to meet the current academic and policy challenges. Apart from conducting full time M.A and Ph.D. programmes, faculty of MSEPP are actively engaged in collaborative activities with various Departments of the State Government, National and International organisations.

WHEREAS Insurance Institute of India is conducting programmes for higher and specialized learning in Insurance through self-learning, e-learning and classroom modes and is carrying on educational programmes in Mumbai in collaboration with its Associated Institutes and Accredited Learning Centre's in and outside Mumbai including other countries.

AND WHEREAS the parties have been collaborating for the purpose of offering post-graduation certificate/ diploma/training courses/programmes in insurance and related subjects for the past seven years under the MoUs signed in July 2013 and July 2015 between the Department of

Economics (Autonomous) (the earlier name of the party of the first part) and the party of the second part. Considering the success of this collaboration, the parties now desire to continue the said collaboration with mutually agreed renegotiated terms and conditions under the present MoU.

NOW, THEREFORE, IT IS HEREBY AGREED TO BY AND BETWEEN THE PARTIES TO SIGN THIS MOU AS FOLLOWS:

1. This MoU supersedes all previous correspondences, discussions, understanding and agreements on the subject matter of this MoU.

2. PERIOD OF THE MoU AND ITS EXTENSION

This MoU comes into effect from August 1st 2020 and will remain in force for 5 years. Its validity can be extended by mutual agreement in writing between the two parties.

3. SCOPE OF COLLABORATION

The following two courses will be conducted in collaboration:

- (a) Post Graduate Diploma in Health Insurance (PGDHI) and
- (b) Post Graduate Diploma in Insurance Marketing (PGDIM) courses

4. ROLES AND RESPONSIBILITIES OF MSEPP

- (a) The syllabi of the courses under the collaboration (or any modification) will require approval of the Academic and Subject Board of the MSEPP.
- (b) MSEPP representative (nominated by the Director of MSEPP) shall be present at the time of interviewing the students for admission to courses under collaboration
- (c) MSEPP representative (nominated by the Director of MSEPP) shall be present at the time of project viva of the students for the courses under collaboration

- (d) MSEPP representatives (two representatives nominated by the Director of MSEPP) shall be members of the Standing Committee, which periodically reviews and monitors the progress of the courses under collaboration.
- (e) MSEPP will attempt to popularize the programme by writing mails, handing over promo literature and displaying advertisements/banners/flyers/notices, the costs of which would be borne by the Insurance Institute of India.
- (f) MSEPP will give support on subjects connected with Economics and Research Methodology.
- (g) Some part of the lectures relating to Economics and Research Methodology should be conducted in the premises of University of Mumbai, subject to availability of classrooms.

5. ROLES AND RESPONSIBILITIES OF INSURANCE INSTITUTE OF INDIA

- (a) The Institute shall in consultation with the said Department undertake the process of admission, put up the admission list and issue admission letters. The fees shall be collected through bankers' cheques/drafts/NEFT in the name of 'Insurance Institute of India'.
- (b) The Institute shall also arrange to fill up the prescribed PG Registration Forms from each student and send the duly completed forms along with all relevant certificates and remit the fees to the said Department on or before the respective dates prescribed by the said Department for its records and for issuance of the PG Registration Number for each student.
- (c) The Institute shall in consultation with the Department conduct examinations, assess the answer papers, and under intimation to the Department declare results of examinations and issue mark-sheets to each student and award diploma certificates to each of the successful students.

- (d) The Institute shall with their expert faculty and staff, deliver the course content in the classroom, conduct and supervise the annual examination and correct the answer papers of the students.
- (e) All expenses relating to teaching, evaluation examinations and incidental charges shall be borne by Insurance Institute of India.

6. DELIVERABLES

- (a) Conduct the Post Graduate Diploma in Health Insurance (PGDHI) and Post Graduate Diploma in Insurance Marketing (PGDIM) courses
- (b) Maintain the quality of the programs by periodic updation of content, selection of appropriate faculty etc.

7. FINANCIAL TERMS AND ARRANGEMENTS

Insurance Institute of India shall remit to MSEPP 30 % of the fees collected per student per year as detailed below.

An amount of Rs.11,400/-, comprising 30% of the fee of Rs.35,250/- per student, and PG Registration fees @825 per student is to be remitted to Mumbai School of Economics and Public Policy, University Of Mumbai.

The University share in full should be remitted within one month of the course beginning irrespective of the number of installments in which the Institute may collect its fees.

8. COORDINATION AND PERIODIC MONITORING

The Courses/Programmes will be conducted by Insurance Institute of India and conduct of Courses/Programmes including selection of teaching/visiting faculty; examinations will be overseen by a Standing Committee consisting of two faculty representatives each of MSEPP and Insurance Institute of India.

The Standing Committee will review the progress of the work periodically; at least once in a year and preferably twice a year.

The Standing Committee for the courses will comprise of the following members:

1. One Professor, MSEPP (nominated by the Director)
2. One faculty, MSEPP (nominated by the Director)
3. One Professor, Insurance Institute of India
4. One Faculty, Insurance Institute of India

9. AMMENDMENTS

This MoU shall be the sole repository of the terms and conditions agreed to between the parties and no amendment thereof shall take effect or be binding on MSEPP and Insurance Institute of India unless such amendment is authorized by The University of Mumbai and Insurance Institute of India, and is recorded in writing and signed by the representatives of MSEPP and Insurance Institute of India.

10. TERMINATION

In case it is found by the two parties that the desired objectives cannot be achieved due to any reason(s) whatsoever, this MoU will be terminated by a mutually agreed procedure without any financial liability on either party.

MSEPP, on the advice of the University of Mumbai, may at any time, after twelve months' written notice, terminate the MoU in whole or in part by requiring Insurance Institute of India to discontinue its association with any or all components of work mentioned herein, in which case Insurance Institute of India shall have no claim against

MSEPP and the University of Mumbai by reasons of such termination. MSEPP and the University of Mumbai shall not be liable to pay any salary, bonus, damages or other claims of Insurance Institute of India for loss of expected profit or interest on the incomplete portions of the work/services.

Insurance Institute of India may terminate the MoU after twelve months' written notice only after clearing all dues if any.

Both parties take due care to ensure that the legitimate interests of the enrolled students are not unduly compromised by such termination. Students would be given two attempts to clear the prescribed examination/viva/project reports within one year of such termination.

11. NO LIABILITY CLAUSE

MSEPP and the University of Mumbai shall not be responsible for any loss or damage to Insurance Institute of India in respect of the subject matter of the MoU and vice versa.

12. ASSIGNMENT

This MoU is not assignable by either party without the prior written consent of the other except that this agreement shall be automatically binding upon and to the benefit of any successor of either party.

13. INTELLECTUAL PROPERTY RIGHTS

The rights in any intellectual property emerging out of the collaborative programme to be carried out under this MoU, will be jointly owned by MSEPP, University of Mumbai and Insurance Institute of India. This, however shall not apply to the work done solely by one party.

14. SETTLEMENT OF DISPUTES

If any dispute arises between the two parties signing this MoU regarding implementation of the terms of the MoU or any other matter incidental to or connected with the subject

matter of the MoU, such a dispute shall be resolved as far as possible amicably by mutual consultations, failing which, a reference may be made by either party to Hon'ble Vice Chancellor, University of Mumbai, whose decision shall be binding on the parties finally and conclusively.

15. CONFIDENTIALITY CLAUSE

The term 'Confidential Information' shall mean any information disclosed by one party ("Discloser") to the other ("Receiver"), pursuant to this MoU or otherwise, which is in written, graphic, machine readable or other tangible form and is marked as 'Confidential' or 'Proprietary' or in some other manner to its confidential nature. Confidential information may also include oral information disclosed by one party to the other, pursuant to this MoU, provided that such information is designated as 'Confidential' at the time of disclosure and reduced to a written summary by the disclosing party, within 30 days after its oral disclosure, which is marked in a manner to indicate its confidential nature and delivered to the receiving party.

For the term of this MoU, each party shall treat as confidential all information of the other party, shall not use such confidential information except as expressly set forth herein or otherwise authorized in writing, shall implement reasonable procedures to prohibit the disclosure, unauthorized duplication, misuse or removal of the other party's confidential information and shall not disclose such confidential information to any third party under this MoU. Without limiting the foregoing, each of the parties shall use the same procedures and degree of care which it uses to prevent the disclosure of its own confidential information of like importance to prevent the disclosure of confidential information disclosed by the other party under this MoU.

16. FORCE MAJEURE

Neither party shall be held responsible for non-fulfillment of their respective obligation under this MoU due to the exigency of one or more of the *force majeure* events such as, but not limited to Acts of God, War, Flood, Earthquakes, Strike(s), Lockout(s), Epidemics, Riots, Civil commotion etc., provided on occurrence and cessation of such

events, the party affected by these shall give a notice in writing to the other party within one month of such occurrence and cessation. If the *force majeure* conditions persist beyond three months, the parties shall mutually decide about the future course of action.

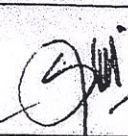
