Arising out of discussion, the following matters were discussed:

- I. Prin. (Dr.) Ravindra Deshmukh, Associate Dean - Faculty of Science & Technology expressed his concern regarding the matter of B.Sc. (Aviation) degree with reference to the news item published in print media. In view of the difficulty faced by learners who have taken admission and completed the three year program but on account of their inability to complete the practicals for pilot training could not be granted the degree of B.Sc. Aviation. This seems to have immense difficulties in perusing career and other academic options. It was **resolved** thereupon to

1. Allow conferring the degree of B.Sc. (Aviation Science) to the learners even if they opt out of the pilot training practicals so that they may pursue other career options.
2. The B.Sc. (Aviation Science) degree be accorded equivalence to other science degree such as B.Sc. (Physics) so that they could pursue higher studies including post graduate degree programs etc. in other science streams.
3. In order to enable granting of equivalence the related ordinances for Post graduate programmes may have to be suitably amended.
4. Since amendment of ordinances could get delayed, a Committee be appointed by the Hon.ble Vice- Chancellor to consider a Vice- Chancellor's Directive for early relief to the affected learners
