Eligibility

- 1) The parents/Guardian annual income shall be **less than or equal to Rs. 2,50,000.**
- 2) Student category shall belong to Scheduled caste or Navboudha
- 3) Student shall belong to resident of Maharashtra
- 4) Student should be passes SSC/equivalent Metric.

Documents Required

- 1) Father Income Certificate (Provided by Tahsildar) for Current Year
- 2) If father is not alive then merge Mother income certificate with father death certificate and upload.
- 3) In case of Married women then merge Husband income certificate with Marriage certificate or Gazette copy for name difference and Ration card front and back copy.
- 3) Aadhar Card of student (linked with Bank Account)
- 4) Domicile Certificate of Maharashtra
- 5) Mark sheet for last appeared examination
- 6) Mark sheet for SSC & HSC
- 7) Gap certificate on Rs.100/-Stamp Paper (in case of Gap in education)
- 8) Self Declaration (if required)
- 9) Cast Certificate.

As per SJ Department instructions, Post-Matric Tuition Fee and Examination Fee (Freeship) is not eligible for Distance mode education.

Eligibility

- 1) The parents/Guardians annual Income should be **less than or equal to Rs.1.50 Lac.**
- 2) Applicant should be belonging to OBC/SBC/VJNT category.
- 3) Applicants must be residents of Maharashtra.
- 4) Only two children (i) any number of girl's applicants allowed. ii) boys' applicants maximum 2 of the same parents will be eligible for the Scholarship.
- 5) Applicant will be eligible for scholarship if he / she changes the course Non – Professional to Professional but he will not be eligible if he / she changes the course from Professional to Non – Professional.

Documents Required

- 1) **Caste certificate** - should be issued by competent authority (Issued by Govt. of Maharashtra) This certificate considered as Proof of Resident.
- 2.) **Income certificate / Income Declaration** - should be issued by competent authority for Current Year
- 3.) **Caste Validity Certificate** – (Mandatory for Professional Degree courses, Professional Post Graduate. For Non-Professional courses caste validity is not mandatory)
- 4.) **HSC or SSC marksheet or last examination marksheet.**
- 5.) **Gap certificate** - Not mandatory but in case of gap it is mandatory.
- 6.) **If applicable father/Guardian's death certificate.**
- 7.) **Ration Card** for identify number of children in family. (Front and back copy)
- 8.) **Leaving Certificate / T.C.**
- 9.) **Declaration certificate of parents/guardians** about number of children beneficiaries.

*** As per Welfare Department instructions, Post-Matric Tuition Fee and Examination Fee (Free ship) is not eligible for Distance mode education.**

Eligibility

- Applicable for ST only
- * If Family Income ≤ 2,50,000, he will get the scholarship
 - * Minimum 10th Pass
 - * Back to back drop for 5 years he/she will not be allowed to fill form.

Documents Required

1. Caste Certificate
2. Income Certificate (Current Years)
3. Previous year's marksheet (H.S.C & S.S.C Marksheet or last examination marksheet)
4. Professional Course selected than caste validity certificate mandatory
5. Domicile Certificate of Maharashtra
6. Leaving Certificate/T.C
7. Ration Card for front & back copy.
