Attention of all the Principals of the all Affiliated Colleges, Recognised Institutions, Heads of the University Departments, Director of the Thane Sub-Campus, Director of the Kalyan Sub-Campus and the Co-ordinators of the Ratnagiri Sub-Campus is invited to Government of Maharashtra Director of Higher & Technical Education letter কুমাক : যুদ্দভাষ /(९३/२२)বিগী-१/१०५६३, বিলাক १० ऑगस्ट, २०२२ The copy alongwith enclosures is attached herewith.

In view above, and in order to avoid financial hardships being faced by parents, it has been decided by UGC that full refund of fees should be made by the Higher Educational Institutions on account of all cancellations of admissions/migrations of students up to October 31, 2022 for the academic session 2022-2023 as a special case due to COVID-19 Pandemic. It is made clear that the entire fee, including all charges, should be refunded (i.e. there should be zero cancellation charges) on account of cancellations/migrations up to October 31, 2022. Thereafter, on cancellation/withdrawal of admissions up to December 31, 2022, the entire fee collected from a student should be refunded in full after deducting not more than Rs. 1000/- as processing fee.

You are also directed to adjust/carry forward the mess charges and hostel fees to all students charged during the COVID-19 Pandemic period.

You are directed to ensure the compliance of refund of fees & carry forward the mess charges and hostel fees in view of COVID-19 Pandemic related factor.
