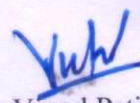
You are hereby informed that the recommendations made by the Ad-hoc Board of Studies in **German** at its meeting held on 22nd April, 2022 and subsequently passed by the Board of Deans at its meeting held on 02nd May, 2022 **vide** item No. 5.26 have been accepted by the Academic Council at its meeting held on 17th May, 2022 **vide** item No. 5.26 and subsequently approved by the Management Council at its meeting held on 25th May, 2022 **vide** item No. 4 that in accordance therewith, mutual transfer of credits as per Memorandum of Understanding between the University of Mumbai and University of Wuppertal, Germany for the M.A. (Hons.) (German Studies) be permitted, recognized and reflected as per Regulation and the same be brought into force with effect from the academic year 2022-23.

R. 9570 : With reference to the Supplementary Cooperation Agreement for the Exchange of Students of the **Memorandum of Understanding** signed between the Universities of Wuppertal and Mumbai on 8th February, 2022 the Department of German, University of Mumbai proposes that, "exchange students shall pursue an academic programme developed in consultation with the student's home institution. Exchange students will be provided with the transcript of records from the host institution, showing the credits and grades achieved, within two months of completing their exchange programme":

1. Candidates enrolled for the M.A. (Hons.) in German Studies (120 credits) programme at the Department of German, University of Mumbai may after the successful completion of the first/second/third semester spend an academic semester at the University of Wuppertal, Germany.
2. The academic courses opted by the candidate at the University of Wuppertal should correspond broadly to the courses offered for that semester at the University of Mumbai. The student shall opt for the courses at the University of Wuppertal, Germany in consultation with the Head, Department of German, University of Mumbai.

3. The credits accrued during the exchange semester at the University of Wuppertal will be recognized and added as cumulative credits for that semester by the University of Mumbai for all examination purposes.
4. The candidates, who spend an exchange semester at the University of Wuppertal, Germany and earn a minimum of 30 credits for the same may be condoned from attending the corresponding semester at the Department of German, University of Mumbai.
