General:

- 1. The candidate can fill online application form of the Entrance Test (PET-2022) for admission to Ph.D. Programme from the link available on University website strictly as per the schedule given above. **No offline forms will be accepted.**
- 2. Every candidate is to ensure that he/she is eligible in all respect as per the eligibility conditions as mentioned in Annexure-I.
- 3. The candidate shall retain the print out of application form for future reference.
- 4. The online link for submitting PET application will be <u>closed at midnight of 12th August, 2022. No request will be entertained thereafter.</u>
- 5. Result will be declared online on a stipulated date after examination. Candidates appearing for the Final Year / Semester of the Master's Degree Programme, as the case may be, of the concerned subject shall be allowed to appear for the online PET 2022. However, the results of PET-2022 of such candidates shall be valid only if they become otherwise eligible for admission to a Ph.D. Programme.
- 6. Fees once paid will not be refunded in any case.
- 7. Candidates are advised to refer the University website www.mu.ac.in for all types of information. No personal communication will be sent to candidates.
- 8. <u>PET will be an eligibility condition to apply for an admission to a Ph.D. Programme.</u> <u>However, it shall not ensure such an admission for Ph.D.</u>
- 9. Revaluation and Photocopy facility for PET is not allowed and request for the same will not be accepted.
- 10. The exact date and time of online entrance test will be announced in due course.

<u>Instructions to Candidates Appearing for Online PET 2022.</u>

- 1. Online PET shall be for Ph. D admissions and shall be conducted as per the declared time table for the same.
- 2. The candidate may give the Online PET from a closed location like a room or a place of residence in a proctored manner.
- 3. The Online PET shall be of 100 Marks and two hours duration.
- 4. There shall be two sections of 50 marks each such that Section-A shall be on Research Methodology and Section-B shall be subject specific. Syllabus for both the sections shall be as pre5cribed by the respective Board of Studies.
- 5. There shall be aggregate passing marks of 50 for candidates belonging to general category and 45 for those from Reserved category.
- 6. There is no provision for photocopy or revaluation for Online PET results.
- 7. Candidates may raise queries relating to their results to the Director, Examinations and Evaluation.
- 8. A Candidate can give Online PET for Ph.D. as per application for the same only in one subject, provided that the candidate is allowed to take the exam in the subject of qualifying examination.
- 9. PET shall be conducted in the Online proctored mode. Details of the proctoring mode shall be provided to the candidates during the mock test that may be conducted.
- 10. Candidates may take a one time Mock Test which will be arranged as per the schedule declared
- 11. In case of technical difficulties regarding login or submission of the test, help desk numbers may be contacted.
- 12. Candidate for the online PET must ensure that he / she has adequate and sufficient internet connectivity at the end. Any grievances in this regard will not be considered.
