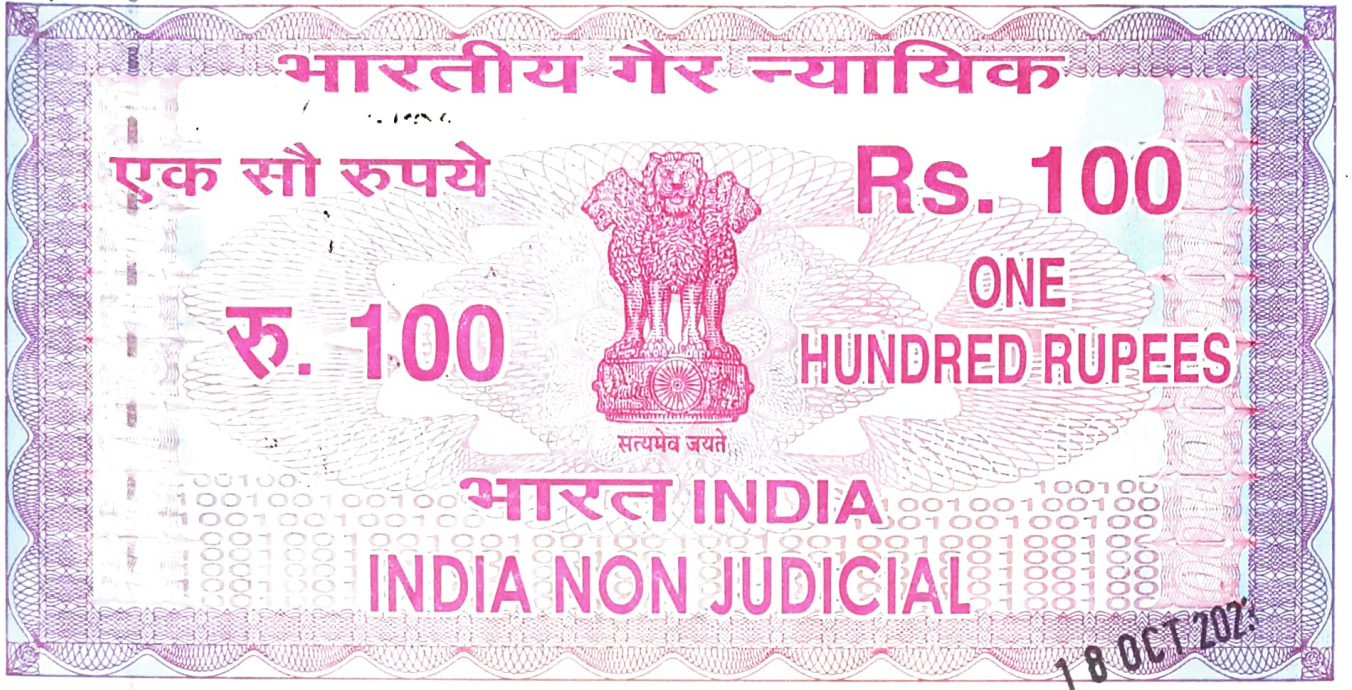
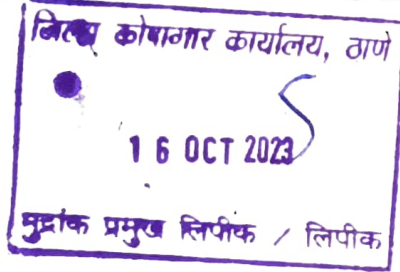

MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (hereinafter referred to as "MOU") is made and entered into as on 19 Day of OCTOBER, 2023 (hereinafter referred to as the "Effective Date"),

AND

University of Mumbai M.G. Road, Fort Mumbai - 400032

Collectively referred to as the "Parties."

WHEREAS, Go Shoonya Pvt Ltd, is India's first start-up by NSS Volunteers and Program officers, a Social Enterprise committed to environmental conservation and sustainable development. Our organization has been actively involved in various projects that promote environmental sustainability and social responsibility. Go Shoonya Pvt Ltd was incorporated on 24th of September 2021 and incubated by MU Ideas.

WHEREAS, the University of Mumbai is an esteemed educational institution committed to promoting sustainable practices and environmental awareness.

WHEREAS, both parties share a mutual interest in promoting a sustainable campus environment and enhancing education through innovative initiatives.

NOW THEREFORE the Parties hereby agree to collaborate and enter into this MOU under the following terms and conditions:

1. Purpose and Scope:

1.1. The purpose of this MOU is to outline the collaboration between Go Shoonya and the University of Mumbai to establish a Miyawaki Forest and Gurukul-type classroom (Open classroom) within the sports complex at the Vidyanagri campus.

1.2. The Miyawaki Forest aims to create a dense, native forest promoting biodiversity and acting as a recreational and educational space. The Gurukul-type classroom aims to provide an open and interactive learning space.



2. Project Overview:

2.1. Go Shoonya, in collaboration with its NGO and CSR partners, will finance, develop, and maintain the Miyawaki Forest and Gurukul-type classroom.

2.2. The University of Mumbai will provide the necessary space within the sports complex at the Vidyanagri campus for the development of the Miyawaki Forest and Gurukul-type classroom.

3. Responsibilities:

3.1. **Go Shoonya Responsibilities:** a. Develop, operate, and maintain the Miyawaki Forest and Gurukul-type classroom. b. Provide necessary expertise, technology, and manpower for the efficient execution of the project. c. Collaborate with CSR partners to secure funding for the project.

3.2. **University of Mumbai Responsibilities:** a. Allocate the specified space within the sports complex for the Miyawaki Forest and Gurukul-type classroom. b. Assist in obtaining required permissions and approvals for the project. c. Collaborate in promoting and implementing educational initiatives within the campus. d. arranging water supply and electric connection as and when required.

4. Financials:

4.1. Go Shoonya will finance the Miyawaki Forest and Gurukul-type classroom project using CSR funds obtained in collaboration with its CSR partners.

4.2. The University of Mumbai will not incur any financial liability for the development, operation, or maintenance of the project.

5. Duration:

This MOU shall be effective from the Effective Date and shall remain in force for a period of 11 Years unless terminated earlier by mutual agreement of the Parties.

6. Termination:

This MOU may be terminated by mutual written agreement of the Parties or in the event of a breach of terms as outlined herein.
