Common Rules and Regulations of all the Hostels of University of Mumbai

EILIGIBILITY FOR HOSTEL ADMISSION

- 1. Only students admitted to a full-time programme of departments/ University institutes of University of Mumbai are eligible to apply for hostel accommodation.
- 2. Admission to the hostel will follow prevailing reservation policy.
- 3. Students who have registered for Ph.D. where daily laboratory work is mandatory may get admission to Hostel. Departments where daily laboratory work is not required, Head of the department will not recommend the students registered for PhD programs for Hostel accommodation.
- 4. Students who accept employment part time or full time will lose their entitlement to hostel accommodation.
- 5. Students residing in Mumbai and suburbs upto Virar, Panvel & Kalyan shall not be considered for hostel admission.
- 6. If a student seeking admission to a higher course of the same level for which he/she was enrolled earlier (like graduation to graduation: masters to masters etc.) by changing subject/faculty shall not be considered for hostel admission. A student completed any PG program in University staying in the Hostel will not be considered for admission to hostel if he secures his admission in any other PG program. Looking at the huge demand and the scarcity of the hostel seats, a student who has availed hostel facility through any program earlier may not be considered for hostel facility for second time.
- 7. Submission of an undertaking that he/she is not resident of Mumbai and suburbs up to Virar, Panvel and Kalyan and do not have his/her or family accommodation / quarters in areas mentioned as above and failing to give correct, information as above shall be liable for termination of hostel admission and also an undertaking that she/he shall abide by all rules and regulations of the hostel.
- 8. The Admission Committee of Wardens will decide for the admission to all the Hostels through online process.

RULES FOR DISCIPLINE

- 1. All the residents of the hostel should see that there is no wastage of water, electricity and other facilities or common utilities provided to them. They shall be always economical in their use. Damages in this regards will be recovered from all students in proportion to the damage done to the property/ establishment of University.
- 2. Students will not disturb their neighbors or others by playing loud music or by creating noise.
- 3. Fans and lights should be put-off before leaving the room. Failures will be fined Rs.100/-per instance. Three such instances will call for expulsion from the hostel.
- 4. The use of electrical (heating, cooking, ironing etc.) appliances and cooking in the rooms is strictly prohibited due to safety requirements of the hostel.
- 5. The cost of damage, (if any) caused due to the electrical installations, furniture etc. in the room or to any of the parts of the hostel premises will be recovered from the student concerned.
- 6. Storage and consumption of alcoholic drinks/drugs/narcotics/intoxicants in the hostel premises is strictly prohibited. Anyone found indulging in these will be expelled instantly from the hostel and be handed over to police. This will hold for smoking also.
- 7. Smoking inside the hostel premises is strictly prohibited. If found doing so, disciplinary action will be taken. Removal from the hostel may also be considered in such cases.
- 8. No student can remain absent from the hostel between 10.00 P.M. to 6.00 A.M. without prior permission of the warden.
- 9. Maximum two late pass & two nights out pass are allowed in a month. Every student should inform the proper address and telephone no of the place where she / he wants to stay for night out.
- 10. Students who are expected to remain absent from the hostel for 10 days or more should fill in the gate pass and ensure that, it is signed by the concerned authority before their departure.
- 11. If the student loses the duplicate key of the room, then he/she has to replace the room lock.
- 12. If any student found to be misbehaving in the hostel the same shall be communicated to the Head of the Department by the Hostel Disciplinary Committee (HDC).
- 13. No student can speak directly to the association/media/police nor shall they allow them to visit the premises of the hostel.
- 14. A student who wishes to Complain about hostel facility to the VC/PVC/Registrar & Police Department the same must be submitted through the Warden.
- 15. There shall be Five-member body of students nominated by HDC, for liaison between students and administration.
- 16. Every student, staying in a University Hostel must bring a certificate of satisfactory attendance and a, recommendation for admission in the subsequent years from Head/Director of the department/Principal of Institution where he/she is enrolled, at the beginning of each term. If a student fails to bring such a certificate and recommendation within the stipulated time period, his/her admission to the hostel will be cancelled immediately without giving any notice.

17. The maximum period of stay allowed in the hostel is as follows.

- 18. The student shall be responsible for the safety of his /her articles, belongings, cash, etc.
- 19. In case, the student is getting UGC/CSIR fellowship he/she shall pay the HRA to the University for staying in the hostel
- 20. NET/JRF students will pay the HRA to the University for staying in the hostel.

PENALTIES

- 1. For entertaining unauthorized guest Rs.250/- per day.
- 2. Remaining away from the hostel for more than 10 days without prior permission Rs.100/-per day.
- 3. Using electrical gadget for cooking & other purpose in the room Rs. 250/-
- 4. Handing over the key to unauthorized persons Rs. 250/-
- 5. Consumption of alcoholic drinks/drugs in the hostel premises Rs. 500/-and/or immediate expulsions.
- 6. Non-payment of hostel fees in due time Rs. 50/- per day till next 10 days or before due date, Admission liable to be cancelled after 10 days of the due date.
- 7. Damage to Property, furniture as per actual expense.

VISITORS / GUESTS

- 1. Visitors are allowed between 9.00 A.M. to 9.00 P.M. (all days)
- 2. No female guests are allowed to enter in the **hostel rooms** in boy's hostels & no male visitors are allowed to enter the girls' hostel.
- 3. It is the responsibility of the student to see that the guest leaves the hostel before 9.00 P.M. The visitors found between 9.00 P.M. to 9.00 A.M. will be considered as an illegal occupant and concerned student will be penalized as per the norm.
- 4. If the student found allowing guests three times illegally in the year then he/she loses hostel admission.
- 5. The guests can be accommodated in the guest room only after the prior permission of the Warden and after filling the Guest Form. Guest needs to deposit the room charges in advance. In girls hostel only female guests and in boys hostel only male guests will be allowed.
- 6. A student of the hostel may be allowed to accommodate a guest for not more than two consecutive nights (only on payment of guest charges as prescribed.)
- The student may accommodate not more than one guest for overnight stay on payment of guest charges.

8. The guest charges are payable on the same day of the arrival of the guest.

Only parents of the medically ill students may visit the hostel and stay for one night free of charge. Thereafter if required to stay on doctor's recommendation, they shall be allowed to stay for three days more at 50% charges.

FEES

- 1. The students need to pay the fees on prescribed due dates every year at the time of taking admission only. Defaulters need to pay Rs. 50/- per day late fee for next ten days. There after the hostel admission will be cancelled.
- 2. Foreign Students will pay five times the fees prescribed for the Indian students.

MISCELLANEOUS

- 1. Students are requested not to bring too many personal belongings, expensive jewelry, large sums of money. Money kept in the room for current use should be locked and the key should be kept with the student himself/herself. University does not hold the responsibility for the loss of anything from the student's room, but in case of any loss, it is to be reported immediately to the Warden.
- 2. While vacating the room, it is the responsibility of the student to get the clearance of dues and handover the key to the office with due signature of the Warden on the counterfoil of the gate pass for no objection. As far as any breakage of hostel property, (i.e. furniture, electrical connections, damage in the room etc.) it will be intimated to the students later.
- 3. Student should submit the gate pass and deposit refund application (if applicable) at least eight working days in advance before vacating/leaving the hostel premises.
- 4. The News Paper, Magazines or any reading materials should be used in the reading room. No one should take these materials outside.
- 5. Student should use dustbins only for disposal of the waste and no one should throw papers or waste materials in the corridors of the Hostel.
- 6. If you are not keeping well, immediately see a doctor. As far as possible, University appointed doctor should be consulted.
- 7. No student will be allowed to use the shower & must use the bucket & mug for bathing and washing.
- 8. Hot water will be available only between 6.30 a.m. to 8.30 a.m & 6.00 p.m. to 07.00 p.m.
- 9. Students of PhD should take NOC before submitting the thesis.
- 10. Students are not allowed to keep animals/ pets in the hostel. They are not allowed to entertain the stray dogs, cats, etc. in the hostel.
- 11. Students with serious ailments/ medical cases like operations/ strokes/ psychological state, etc. should submit the report and copy of medical advice to the warden for timely and immediate help in case of emergency.
- 12. Only National Days such as Independence Day, Republic day, will be celebrated in the Hostel. Any other celebration/ festival to be observed in the hostel may be decided at the discretion/ responsibility of the committee of the wardens.
- 13. Students should take food/all meals in mess area only. They are not allowed to take meals/food in the hostel room. In case of illness /medical reason, contact hostel warden for permission for few days.
