Reopening of eSamarth Portal for Applications to M.Sc. Chemistry
Admission for the Academic year 2024-25

It is hereby notified to the students seeking admission for the M.Sc. Degree (NEP based) programs at the University Department of Chemistry (Autonomous), University of Mumbai that the link for application form will remain open from Monday, 15th July 2024 to Thursday, 18th July 2024 (up to 6.00 p.m.).

The candidates who applied previously for all branches need not apply again.

Department of Chemistry (Autonomous), University of Mumbai, conducts following M.Sc. Degree programs,

I. Aided Programs

- Physical Chemistry (20 Seats)
- Inorganic Chemistry (20 Seats)
- Organic Chemistry (20 Seats)
- Analytical Chemistry (20 Seats)

II. Unaided Program

- Industrial Polymer Chemistry (15 Seats)

It is hereby notified that the students seeking admission for the above M.Sc. Degree (NEP based) programs at the University Department of Chemistry (Autonomous), University of Mumbai are required to follow the procedure given below:

- A. The candidate should fill the online application form through the **eSamarth Portal** of University of Mumbai, the link for the online application is:

- B. Candidates are required to fill the necessary information carefully as per the instructions given in the online application form.

- C. Candidates must apply for all the interested programs (Physical Chemistry / Inorganic Chemistry / Organic Chemistry / Analytical Chemistry / Industrial Polymer Chemistry) separately, failing to which their candidature shall not be considered for programs for which they have not applied.

D. Additional Instructions:

1. Students of Mumbai University should upload SEM-5 & SEM-6 Mark sheet or Mark Statement. Other University students should upload (SEM-1 to 6) Mark Sheet.
2. Reserved category students, SC/ST/DT/NT/OBC/SBC should upload valid caste certificate.

3. DT/NT/OBC/SBC students should upload the Non-creamy layer certificate of the current financial year 2024-2025.
4. Certificate of EWS category of the current financial year 2024-2025 should be uploaded.
5. Caste Certificate and Non-creamy layer certificate of SEBC for the current financial year 2024-2025 should be uploaded.
6. Orphan category students should upload the valid certificate.
7. Physically Disabled/Handicapped students should upload a valid certificate.
8. Students belonging to wards of the Central / State Govt. employees/officers who have been transferred; wards of the present/past defense personnel; students obtaining dexterity at national / state level sports/ cultural activities; widow / deserted female students; wards of the freedom fighters should upload the valid certificate.

Online verification of documents by the Department	:	Up to Friday, 19 th July 2024 (up to 3.00 p.m.)
Display of Merit List	:	Friday, 19 th July 2024 (up to 6.00 p.m.)
Spot Round of Admission (Offline)	:	Saturday, 20 th July 2024 (10.00 a.m. onwards)
Payment of Fees	:	Saturday, 20 th July 2024 to Monday, 22 nd July 2024 (up to 6.00 p.m.)
