➤ Prof R. D Kulkarni, Former Pro-Vice Chancellor and the Chairman of the NEP Committee invited as Special Invitee for the Academic Council Meeting.

Hon,ble Vice-Chancellor welcomed and congratulated Prof R. D Kulkarni Sir for his efforts on preparing report on Structure and curriculum of four year and dual multidisciplinary degree programme with multiple entry and exit options for implementation of NEP 2020 in the State Universities of Maharashtra.

Prof R. D Kulkarni explained the report in brief.

After due discussion and deliberations on the matter, it was resolved that –

- 1) NEP 2020 will be implemented from the A.Y. 2023-24.
- 2) First Semester Examinations of all programmes a.y.2023-24 will be shifted as per NEP Policy and subsequently next semester examinations.
- 3) Circular be issued directing the affiliated colleges/institutions/ to mandatorily registered themselves on ABC via NAD and efforts be taken to inform all students to register and get Unique id through colleges/institutions.
- 4) Meetings/Discussions with Principals/Faculties/new BOS be arranged regarding NEP 2020.
- 5) The Core - Committee be formed for preparing action plan for implementation of the NEP 2020 as per the NEP report. The committee will work under the following jurisdictions:-
 - a. The Core - Committee should prepare action plan with time-line for the whole implementation.
 - b. The Committee should prepare draft rules/regulations in line with the NEP 2020 as existing Ordinances and Regulations to the existing programmes need to be modified and those Regulations, which are not consistent should be repealed/replaced accordingly. (Regulation needs to be modified as far as 3rd and 4th year option is concerned. Students

should be given idea whether they can go for distance mode or online mode.)

- c. Guidelines for examinations part as far as software concerned. (modifications need to be informed to technical team and completed in time with testing, as first Semester Examination will be shifted to new NEP 2020 Policy and subsequently next semester examinations .
- d. Guidelines for Basket of Skilled/Soft skills courses/Courses under Swayam/Online courses from University side/IDOL distance common courses needs to be prepared.

6) The Hon'ble Vice-Chancellor be authorised to form a Core-Committee.

7) The Core-Committee will submit its report before 31st March, 2023.

8) The Report of the Core-Committee will be placed before Academic Council through the Board of Deans

The Committee should prepare draft rules/regulations in line with the NEP 2020 as existing Ordinances and Regulations to the existing programmes need to be modified and those Regulations, which are not consistent should be repealed/replaced accordingly. (Regulation needs to be modified as far as 3rd and 4th year option is concerned. Students should be given idea whether they can go for distance mode or online mode.) c. Guidelines for examinations part as far as software concerned. (modifications need to be informed to technical team and completed in time with testing, as first Semester Examination will be shifted to new NEP 2020 Policy and subsequently next semester examinations . d. Guidelines for Basket of Skilled/Soft skills courses/Courses under Swayam/Online courses from University side/IDOL distance common courses needs to be prepared. 6) The Hon'ble Vice-Chancellor be authorised to form a Core-Committee. 7) The Core-Committee will submit its report before 31st March, 2023. 8) The Report of the Core-Committee will be placed before Academic Council through the Board of Deans.
