IAP-39, R. IAP-40, R. IAP-41 for M.P.A. (Music-Hindustani) M.P.A. (Vocal) has been brought into force with effect from the academic year 2024-25 as per NEP:-

## Regulation for M.P.A. (Music-Hindustani) M.P.A. (Vocal)

# R.: <u>CARRY FORWARDS OF MARKS IN CASE OF A LEARNER WHO FAILS IN WHO FAILS IN THE INTERNAL ASSESSMENT AND/OR SEMESTER END ASSESSMENT IN ONE OR MORE SUBJECTS</u>:

- A learner who PASSES in the Internal Examination but FAILS in the Semester End Examination of the course shall reappear for the Semester End Examination of that course. However, his/her marks of the Internal Examinations shall be carried over and he/she shall be entitled for grade obtained by him/her on passing.
- 2) A learner who PASSES in the Semester End Examination but FAILS in theInternal Assessment of the course shall reappear for the Internal Examination of that course. However, his/her marks of the Semester End Examination shall be carried over and he/she shall be entitled for grade obtained by him/her on passing.

#### R. IAP-40

## R.: ALLOWED TO KEEP TERMS (ATKT):

a. A learner shall be allowed to keep term for Semester II irrespective of number of heads of failure in the Semester I.

b. A learner shall be allowed to keep term for Semester III if he/she passes each of Semester I and Semester II.

OR

A learner who fails in not more than two courses of Semester I and Semester II taken together.

- c. A learner shall be allowed to keep term for Semester IV irrespective of number of heads of failure in Semester III. However, the learner shall pass each course of Semester I and Semester II in order to appear for Semester IV.
- d. The result of Semester IV shall be kept in abeyance until the learner passes each of Semester I, Semester II, Semester IV if the learner is taking exit from the program at semester IV.

#### R. IAP-41

#### R.: PROJECT EVALUATION (IF APPLICABLE):

- 1. A learner who passes in all the courses but does not secure minimum 40% in project as applicable has to resubmit a fresh project till he/she secures a minimum of 40%
- 2. The credits and grade points secured by him/her in the other courses will be carried forward and he/she shall be entitled for grade obtained by them on passing of all the courses.
- 3. The evaluation of project and viva-voce examination shall be done by marks only and then it will be converted into grade and award the same to the learner.

4. A learner shall have to obtain minimum of 40% in project evaluation and viva-voce Balirowh taken together to obtain 40% marks in project work.
