Attention of the Principals of the Affiliated Colleges, and Directors of the Recognized Institutions in Faculty of Science and Technology is invited to this office circular No. UG/33 of 2020-21 dated 11th November, 2020 relating to the i) Regulations 8435 the existing scheme of evaluation (UG Programme) be replaced by 75:25 old evaluation scheme with appropriate break up of 25% under CBCS (ii) R.8435 PG programme a) 80:20 for distance education (external evaluation 80 marks, internal 20 marks) under CBCS ,b) 60:40 for university affiliated PG centers (external evaluation 60 marks and external 40 marks) under CBCS w.e.f. academic year 2020-21.

They are hereby informed that the recommendations made by the **Board of Studies in Botany** at its meeting held on 06th May, 2024 and subsequently passed by the Board of Deans at its meeting held on 18th May, 2023 vide item No. 6.2 (A) have been accepted by the Academic Council at its meeting held on 24th May, 2024 vide item No. 6.2 (A) and that in accordance therewith, the **Scheme of Examination Evaluation Pattern (Theory)** for S.Y.B.Sc. and T.Y.B.Sc. Botany (Major and Applied Component) be changed to 75:25 Pattern instead of the 100 marks pattern as per appendix from the academic year 2024-25.

S.Y.B.Sc. and T.Y.B.Sc. Evaluation pattern

1. Changing the Evaluation pattern (Theory) for SYB.Sc. and TYB.Sc. Botany to 75:25 Pattern instead of the 100 marks pattern from the academic year 2024-25.

It was **resolved** that the Evaluation pattern (Theory) for SYB.Sc. and TYB.Sc. Botany (Major and Applied component) be changed to a 75:25 Pattern instead of the 100 marks pattern from the academic year 2024-25, Place for Bod and further process.

- a) The Internal evaluation of 25 marks will include
 - i) Assignments/tutorials / class tests/seminars, etc. - 20 marks
 - ii) Participation and attendance - 05 marks.
- b) The External evaluation will include a semester-end examination of 75 marks question paper with the following pattern:
- c) **S.Y.B.Sc.**
 - i. MCQs - 15 marks (Any 15 to be attempted out of 20)
 - ii. Subjective Questions based on 3 units (15 marks each with 100% options)
 - iii. Mixed Question based on 3 units (Any 3 to be attempted out of 6)
- d) **T.Y.B.Sc.**
 - i. MCQs - 15 marks (Any 15 to be attempted out of 20)
 - ii. Subjective Questions based on 4 units (15 marks each with 100% options)
- e) Practical examinations for SYB.Sc.(150 marks) and TYB.Sc. (200 marks for Major and 100 marks for Applied Component) will be conducted as per the existing pattern.
