They are hereby informed that the recommendations made by the Ad-hoc Board of Studies in Music at its meeting held on 11<sup>th</sup> January, 2024 and subsequently passed by the Board of Deans at its meeting held on 18<sup>th</sup> April, 2024 <u>vide</u> item No. 8.6 (A) have been accepted by the Academic Council at its meeting held on 20<sup>th</sup> April, 2024 <u>vide</u> item No. 8.6 (A) and that in accordance therewith the amendment of R.9452 relating to standard of passing for PG Diploma in Proficiency in Playback Singing and Stage Performance be effected from the academic year 2024-25 and the same is read as under:-

# Amendment of R. 9452 relating to the standard of passing for PG Diploma in Proficiency in Playback Singing and Stage Performance.

### The Existing R. 9452:-

- \* To pass in practical papers student must secure minimum 50 percent marks in each practical paper. To pass in theory papers, a student must secure minimum 40 percent marks in each.
- \* To pass a student must earn at least 45% of marks combining both theory and practical papers.

#### The Amended R. 9452:-

To pass in practical papers student must secure minimum 50 percent marks. To pass in theory papers student must secure minimum 40 percent marks. To pass in Projects/seminars/ submission the student must secure minimum 40 percent marks. For

overall student passing must secure total 45 percent marks theory/practical/projects/submissions all inclusive.
