GUIDELINES FOR SECOND ROUND OF FIRST YEAR LL.M. ADMISSION PROCESS 2024-2025

ALL CANDIDATES WHOSE NAMES ARE DISPLAYED IN THE SECOND ROUND OF THE LL.M. ADMISSION MERIT LIST 2024-25 ARE INFORMED TO PARTICIPATE IN THE SECOND ROUND OF LL.M. ADMISSION-RELATED PROCESS FROM 29/01/2025 TO 30/01/2025.

GUIDELINES FOR SECOND ROUND OF FIRST YEAR LL.M. ADMISSION PROCESS 2024-2025 ARE AS FOLLOWS:-

- 1. Those candidates who have been admitted as students in the first round with first preference are not eligible to participate in the second round of LL.M. admission process, 2024-2025.
- 2. Candidates who have failed to take admission in the first round of LL.M. admission process despite their name having appeared in the list of the first round of the LL.M. admission, are not eligible to participate in the second round of LL.M. admission process.
- 3. Candidates who have taken admission in the first round and admitted in the second or subsequent preferences of his/her choice are also eligible for the second round of LL.M. admission process provided there is a vacancy in the higher preference of his/her group. However, the admission in the second round shall take place strictly according to merit, reservation norms of the Government and subject to the availability of vacancy in the group.
- 4. The names of candidates in the Second Round of Admission are notified on the website of the University of Mumbai and displayed on the notice board i.e. https://mu.ac.in/department-of-law
- 5. The Second round of merit list is prepared according to the Merit and eligibility norms of the University of Mumbai.
- 6. The candidates are required to remain present personally at the Department of Law Room No. 123, First Floor, Department of Law, University of Mumbai, Fort Campus, Mumbai-400 032 as per the schedule of the First year Second round of LL.M. admission mentioned herein below:

- 7. The admission process will start by calling upon candidates as per the merit list for the second round of LL.M. admission. The seat will be allotted to the candidate as per vacant seats available in a particular category of each group.
- 8. The verification of documents and admission process will be conducted in Room No. 124.
- 9. The LL.M. admission process shall be subject to verification of original documents. Candidates are required to keep ready all relevant scanned documents and hard copies of the original documents for the purpose of verification of documents. If Candidate fails to produce relevant original documents at the time of verification, then his / her claim for admission shall stand cancelled.
- 10. If a candidate is absent when called for admission, the opportunity will be given to the next present candidate in the Law Department. Vacant seats will be allotted based on the second merit list. Candidates who fail to report as per the schedule will forfeit their claim to the seat, and the seat will be assigned to the next eligible candidate. Late-reporting candidates will only be considered for any vacant seats available in their respective category at the time they report to the admission office during working hours on the same day. Candidates who do not report as per the prescribed schedule outlined below will lose their chance for admission and will not be considered for any subsequent or consequential rounds of LL.M. admissions for 2024-2025.
 - 11. After confirmation of admission, candidates of the Second Merit List are required to do online Registration immediately by submitting two copies of the Pre-Registration Form along with the admission form to the Law Department office in Room No. 124. The candidate is required to submit two copies of Passport size photographs.
- 12. Candidates who secured admission in the first round of the LL.M. admission process based on their second or subsequent preferences and paid the admission fees are not required to register or pay the fees again if upgraded to a higher preference based on merit in the second round of LL.M. admission.
- 13. After the seats are allotted as per the General Merit List, the admission process of the Second round of LL.M. admission will be completed and closed. If there are any vacant seats in the Reserved Category or General Category, the LL.M. Third Round of Admission will be completed by allotting vacant seats to remaining candidates.
- 14. The Candidates whose names are displayed in the Second Round of Admission Merit List but who have failed to report for admission on the notified date as per the prescribed schedule given as under, will not be considered for the Third Round of LL.M Admission. Under any

circumstances, a request for a time extension or any other reason will not be entertained.

- 15. The candidates are informed to bring all original relevant documents for verification and scrutiny. The scrutiny of documents will be done in Room No. 124.
- 16. The Pre-Registration Form should be attached to the admission form at the time of Verification of the document.
- 17. After the verification of documents, the Department of Law will approve the LL.M. admission of the candidate.
- 18. After approval of admission the Department of Law will provide details to the candidate for payment of Admission fees.

Admission Fees is to be paid online (NEFT/RTGS/UPI/QR Code).
