CIRCULAR:-

Attention of all the Principals of the Affiliated Colleges, Directors of the Recognized Institutions and the Head, University Departments is invited to this office Circular No. AAMS_UGS/ICC/2022-23/168 dated 17th November, 2022 regarding introduction of 75:25 CBCS from 2022-23.

They are hereby informed that the recommendations made by the **Board of Studies in** Law at its meeting held on 30th October, 2024 and subsequently passed by the Board of Deans at its meeting held on 30th November, 2024 <u>vide</u> item No. 8.13 (N) have been accepted by the Academic Council at its meeting held on 4th December, 2024 <u>vide</u> item No. 8.30 (N) and that in accordance therewith is revised the Examination Pattern for the LL.B (3 years) and LL.B (5 years) from the academic year 2024-25.

The students who have enrolled and taken admission and are pursuing their law degree as per 60:40 pattern, including regular and ATKT category or appearing for the exam after a gap for examination held in November- December 2024 (academic year 2023-24), not being a regular student of 75:25 pattern, will appear in 60:40 pattern and from the year 2024-25 after taking regular admission in 75:25 pattern, will have to appear in examination as per 75:25 pattern.

Clarification as below:-

- 1. LLB 3yrs 60:40- Introduced in 2019-20 and 75:25 Introduced in 2022-23 with revised syllabus. The revised syllabus introduced in 2022-23 shall be the syllabus to be taught from the year 2022-23 progressively and no revival of the old syllabus can be thought of after the new syllabus has been implemented. Therefore, the subjects for all students admitted in 2022-23 in the first year had been as per revised syllabus of 2022-23. In 2023-24 old students of 100 markspattern/ 60:40 pattern admitted with regular students of 75:25 shall also have the new syllabus (University circular dated 26th June 2023). In the same way old students of 100 marks pattern/ 60:40 pattern admitted into 3rd year along with 75:25 students in 2024-25 shall have the new syllabus. Therefore, all the students currently admitted to third year (2024-25) will have CPC, BNSS, Labour and Industrial Relations II and Public International Law, Practical Training III. These were the courses expected to be taught by the colleges after change of syllabus notified in 2022-23.
- 2. LLB3yrs All the regular students of Semester V will appear in semester examinations in the revised courses as mentioned in Point no. 1. The question paper will be of 75 marks for all regular students admitted in the present academic year. The marks obtained will be scaled down as per 60:40 for the purpose of issuing the mark sheets
- 3. LL B 5yrs 75:25 has caught up with semester V. There are no changes in the courses as of now. In Nov 2024 Semester IX exams, students will appear in 60:40 and in old syllabus. The subjects will be CPC, BNSS, IOS, PILHRs and Practical Training.

4. Regarding Labour Law paper-

As per the revised syllabus of university of Mumbai, Labour Law subject is divided into-Labour Law and Industrial relations. I

Labour Law and Industrial relations II.

Those students who have already appeared for Labour law in the semester V of BA LL.B 5 years course and SEM I of three years LL.B course as per old pattern, will have to appear for Labour Law and Industrial Relations- II in semester V of three years LL.B course and Semester IX of 5 years B A. LL.B course as content of the course is different. (Irrespective of 60:40 or 75:25 pattern, all students will be required to appear for the Labour law and Industrial Relations - II)

5. Regarding Cr. P.C and Bharatiya Nagrik Suraksha Sanhita (BNSS)

Criminal Procedure Code henceforth should be read as Bharatiya nagarik Suraksha Sanhita. 2023. The syllabus of Bharatiya nagrik Suraksha sanhita has already been notified and implemented from 1st of July 2024. Students/ teachers should note that teaching learning for this subject will be as per the content of BNSS 2023 and not CrPC 1973. For the upcoming examination (NOV -DEC 2024) the syllabus for this subject is BNSS 2023, JJ act 2015 and POCSO 2012.

6. Regarding Taxation Subject

As per the new law syllabus, Taxation subject has been made compulsory for LL.B 3 years course semester VI and BA LL.B 5 years course semester X.

- (A) LLB 3yrs- Semester VI that will commence in January 2025 shall have the revised syllabus. The students from old 100 marks pattern/60: 40 pattern who are admitted thisyear along with 75:25 students and so to be admitted in future years will study Arbitration, Conciliation and ADR (ACADR) instead of Law of Taxation (compulsorycore paper) if they have studied Law of Taxation as an elective in their respective semester IV under the old syllabus. The syllabus for the Arbitration, Conciliation and ADR (ACADR) shall be as prescribed earlier in the old syllabus. The college shall conduct classes for the course like any other course and show in the time table as Taxation/ACADR.
- (B) LLB 5yrs- whatever is stipulated in Point no. 6 (A), shall mutatis mutandis apply to students of 5yr LLB in 2026-27 when semester IX and X of LLB 5yrs will get subsumed under 75:25.
