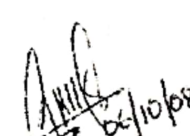

R.4852 :- Standard of Passing : To pass the examination, a candidate must obtain 40% of marks in each of the three papers under each head of passing (written examination as well as practical).

Those of the successful candidates who obtain 60% or more of the total marks at one and the same examination will be placed in the First Class and those who obtain 50% or more of the total marks but less than 60% of the total marks at one and the same examination will be placed in the Second Class. All others getting 40% or more of the total marks but less than 50% of the total marks will be placed in the Pass Class.

In case of the candidate who appears for the examination and fails or does not appear in the theory papers, the marks obtained in practical and in the theory shall be carried over, at his/her option, to three subsequent examinations. Candidates exercising this option will not be eligible for First or Second Class.
