

CIRCULAR :-

A reference is invited to the Ordinances, relating to the B.E. degree course (Full Time) vide pamphlet No.203 and to this office Circular No.UG/312 of 1997 dated 5th September, 1997 and the Principals of the affiliated colleges in Engineering are hereby informed that the recommendations made by the Faculty of Technology at its meeting held on 15th March, 2005 has been accepted by the Academic Council at its meeting held on 2nd April, 2005 vide item No.4.19 and subsequently approved by the Management Council at its meeting held on 16th April, 2005 vide item No.11 and in exercise of the powers conferred on the Management Council under Section 54(1) of the Maharashtra Universities Act, 1994, the Management Council has amended Ordinances 3723, 3727 and 3731 relating to the B.E. degree course which read as under :-

O.3723 :- A candidate for being eligible to appear for Semester IV of the Second Year Engineering examination should have satisfactorily kept the terms for Semester IV. However, a candidate who has failed in not more than 4 Heads of passing in Semesters I and II taken together and who has satisfactorily kept the terms for Semesters III and IV, will also be permitted to appear for Semester IV examination.

O.3727 :- A candidate for being eligible to appear for Semester VI of the Third Year Engineering examination should have satisfactorily kept the term for Semester VI. However, a candidate who has failed in not more than 4 Heads of passing in Semesters III and IV taken together and who has satisfactorily kept the terms for Semester V and VI will also be permitted to appear for Semester VI examination.

O.3731 :- A candidate for being eligible to appear for Semester VIII of the Final Year Engineering examination should have satisfactorily kept the term for Semester VIII. However, a candidate who has failed in not more than 4 Heads of passing in Semester V and VI taken together and who has satisfactorily kept the terms for Semesters VII and VIII will also be permitted to appear for Semester VIII examination.

Further that the amended Ordinances 3723, 3727 and 3731 relating to the B.E. degree course have been brought into force with effect from the academic year 2004-2005.
