Attention of the Head, University Department of Education, the Principals of Affiliated Training Colleges and Director, Ali Yavar Jung National Institute of Hearing Handicapped is hereby invited to the Ordinances, Regulations and Syllabi relating to the B.Ed. (Hearing Impairment) vide pamphlet No.86 and to this office circular No. UG.370 of 2003 dated 1st August, 2003 and they are hereby informed that the recommendation made by the Board of Studies in Education at its meeting held on 28th September, 2006 has been accepted by the Academic Council at its meeting held on 10th November, 2006 vide item No.4.14 and subsequently approved by the Management Council at its meeting held on 29th November, 2006 vide item No.9 and that in accordance therewith Regulation 4307 relating to B.Ed. (H.I.) examination is amended to read as under:-

R.4307 :-

A candidate who fails in Part A and Part B fully or partially is allowed to re-appear only for a maximum of 3 consecutive attempts.

(i) For Part - A:

- The candidate failing in individual Paper/s of Part A will have to reappear for that papers/s only. His/Her internal marks will be carried forward in such instances. However, he/she will be declared pass in the Part A only when he/she scores an aggregate of 45%.
 - If the candidate passes in all the individual papers of Part

 A but fails to secure the aggregate of 45% he/she has to reappear for all the papers. His/her internal marks will be carried forward in such instances. The additional theory work required is mentioned in R-4312.

(ii) For Part - B:

- The candidate failing in individual practical area/s of Part

 B will have to re-appear for that practical area/s only.
 His/her marks in all the other practical areas will be carried forward in such instances. However, he/she will be declared pass in the Part B only when he/she scores an aggregate of 45%.
- If the candidate passes in all the individual practical area/s of Part – B, but fails to secure the aggregate of 45%, he/she has to reappear for all the practical areas.
 The additional practical work required is mentioned in R-4311.

For failing in both Part -A and Part -B (ii)

A candidate failing in both Part - A and Part - B will be required to repeat the additional work of Part - B as mentioned in R-1311. For Part-A the candidate can reappear for the examination without putting in attendance in college. Such candidate/s opting for all the above options (i), (ii) and (iii) shall not be eligible for a first or second class.
