A reference is invited to the Ordinances, Regulations and syllabi relating to the Bachelor of Management Studies (B.M.S.) degree course vide Pamphlet No.309 and to this office Circular No.UG/207 of 2003 dated 22nd May, 2003 and the Principals of the affiliated colleges in Commerce are hereby informed that the recommendation made by the Faculty of Commerce at its meeting held on 3rd April, 2007 has been accepted by the Academic Council at its meeting held on 13th April, 2007 vide Item No.4.35 and subsequently approved by the Management Council at its meeting held on 20th April, 2007 vide Item No.26 and that in accordance therewith Ordinance 3941 relating to the Bachelor of Management Studies (B.M.S.) degree course is amended to read as under :-

"O.3941 :- A candidate for being eligible for admission to the B.M.S. degree course shall have passed XIIth Std. Examination of the Maharashtra Board of Higher Secondary Education or its equivalent examination or Diploma in any Engineering branches with two years or three years or four years duration after the S.S.C. conducted by the Board of Technical Education, Maharashtra States or equivalent examination.

The amended Ordinance 3941 relating to the B.M.S. degree course will be brought into force with effect from the academic year 2007-2008. "
