Please refer to this office Circular No.UG/543 of 2003, dated 3rd November, 2003 in respect of the Ordinances. Regulations and Syllabi relating to the B.Sc. (Aviation) degree course vide Pamphlet No.355. In this connection, I am to inform you that the recommendation made by the Faculty of Science at its meeting held on 23rd February, 2004 has been accepted by the Academic Council at its meeting held on 2nd April, 2004 vide item No. 4.27 and that in accordance therewith, the following clarifications has been issued on Circular No. UG/543 of 2003, dated 3rd November, 2003 regarding the Regulation relating to the Standard of Passing for the B.Sc. (Aviation) degree course:

Clarification on 70% marks required for certain examinations papers related to Aviation Safety

Besides passing the practical examination of 100 marks at F.Y. and S.Y.B.Sc. (Aviation) conducted by the institute on behalf of University a student has to clear six examinations conducted by the Director General of Civil Aviation. After passing these examination a student is awarded Commercial Pilot License (CPL). A B.Sc. (Aviation) degree is awarded to a student only when he passes the B.Sc. (Aviation) examinations and obtains Commercial Pilot License (CPL)

List of Examinations a student has to pass to obtain COMMERCIAL PILOT LICENSE (CPL) is given below:

- 1) PPL (G) Composite (Private Pilot License)- Paper I
- 2) PPL Paper II (Technical)
- 3) FRTOL (R) (Flight Radio Telephone Operators License-Restricted)
- 4) FRTOL (Flight Radio Telephone Operators License),
- 5) CPL (Commercial Pilot License) consisting of 3 papers –
 Paper I Air Navigation
 Paper II Aviation Meteorology
 Paper III Air Regulations

6) Pilot Technical Examinations: consisting of 2 papers – Paper I - Aircraft Technical General Paper II- Aircraft Technical Specific.

A student has to pass all the above examinations, which are conducted by CENTRAL EXAMINATION ORGANISATION. This organization is headed by DIRECTOR GENERAL OF CIVIL AVIATION (DGCA).

For all these examinations the passing percentage is 70% and within two years the student has to clear all these examination.

Thus there will be two kinds of Practical Examination. One conducted by the college where passing percentage will be 35% marks and all these examinations listed above (1 to 6) will have 70% passing criteria; conducted by the DGCA.
