Pattern of Question Paper

Item 2 :

T.Y.B.Sc. (Botany) Theory Examination :

Each paper contains four units. One question should be set from each unit with an internal option. The fifth question should include short notes on topics from each of the four units.

M.Sc. Part I and II (Botany) Theory Examination

Each question paper should comprise of five questions with internal option for each question. All questions are compulsory.
