A reference is invited to the Ordinances, Regulations and Syllabi relating to the Bachelor of Architecture (B.Arch.) degree course vide Pamphlet No.165 and to this office Circular No.UG/103 of 2001 dated 28th March, 2001 and Principals of the affiliated colleges in Architecture are hereby informed that the recommendation made by the Ad-hoc Board of Studies in Architecture at its meeting held on 11th March, 2004 has been accepted by the Academic Council at its meeting held on 2nd April, 2004 vide item No. 4.53 and that in accordance therewith, Semester VI examination at the B.Arch. degree course, under the old scheme will be held for the last time in the first half of the year 2005 and that the candidates who have appeared and passed Semesters V and VI examinations under the old scheme will be allowed to take admission to the Fourth Year of the revised B.Arch. degree course, as a special case, in the academic year 2004-2005, subject to the condition that such candidate should study and pass Landscape subject as per the syllabus prescribed for the Third Year of the revised B.Arch. degree course, without keeping terms, as a special case, however the result of such candidates shall not be declared, unless they pass Landscape subject of the B.Arch.(Third Year) revised course.
