A reference is invited to the Ordinances relating to the Bachelor of Architecture degree course (B.Arch.) vide Pamphlet No. 165 and to this office Circuar No. UG/103 of 2001 dated 28th March, 2001 and the Principals of the affiliated colleges in Architecture are hereby informed that the recommendation made by the Ad-hoc Board of studies in Architecture at its meeting held on 28th April, 2005 has been accepted by the Academic Council at its meeting held on 14th June, 2005 vide item No.4.26 and subsequently approved by the Management Council at its meeting held on 18th June, 2005 vide item No.4 and that in accordance therewith Ordinances 5006, 5007, 5008, 5009, 5010, 5012, 5013, 5014 and 5015 relating to the First Year, Second Year, Third Year, Fourth Year and Fifth Year B.Arch, degree examinations have been amended to read as under:-

O.5006:- ELIGIBILITY CRITERIA FOR FIRST YEAR ARCHITECTURE EXAMINATION.

A candidate for being eligible for the First Year Architecture Examination:-

- a) must have kept satisfactory attendance for two academic terms of the First Year.
- must have obtained minimum Sessional marks for passing all internal subjects heads for passing the First Year Examination.

O.5007 :-ELIGIBILITY CRITERIA FOR ADMISSION TO SECOND YEAR ARCHITECTURE.

A candidate for being eligible for admission to the Second Year of Architecture:-

- a) must have kept satisfactory attendance for two academic terms of the First Year.
- b) must have obtained minimum Sessional marks for passing all internal subjects heads of passing for the First Year of Architecture.

O.5008 :-ELIGIBILITY CRITERIA FOR SECOND YEAR ARCHITECTURE EXAMINATION.

A candidate for being eligible for the Second Year Architecture Examination:-

- a) must have passed the First Year Architecture Examination.
- b) must have kept satisfactory attendance for two academic terms of the Second Year.
- e) must have obtained minimum Sessional marks for passing all internal subjects heads for passing the Second Year Examination.

O.5009:- ELIGIBILITY CRITERIA FOR ADMISSION TO THIRD YEAR ARCHITECTURE.

A candidate for being eligible for admission to the Third Year of Architecture:-

- a) must have passed the First Year Architecture Examination.
- b) must have kept satisfactory attendance for two academic terms of the Second Year.
- must have obtained minimum Sessional marks for passing all internal subjects heads for passing for the Second Year of Examination.

<u>O.5010</u>:- ELIGIBILITY CRITERIA FOR THIRD YEAR ARCHITECTURE EXAMINATION.

A candidate for being eligible for the Third Year Architecture Examination:-

a) must have passed the Second Year Architecture Examination.

- b) must have kept satisfactory attendance for two academic terms of the Third Year.
- c) must have obtained minimum Sessional marks for passing all internal subjects heads for passing the Third Year Examination.

O.5012 :-ELIGIBILITY CRITERIA FOR ADMISSION TO FOURTH YEAR ARCHITECTURE.

A candidate for being eligible for admission to the Fourth Year of Architecture:-

- a) must have passed the Second Year Architecture Examination.
- b) must have kept satisfactory attendance for two academic terms of the Third Year.
- c) must have obtained minimum Sessional marks for passing all internal subjects heads for passing for the Third Year Examination.

O.5013 :-ELIGIBILITY CRITERIA FOR FOURTH YEAR ARCHITECTURE EXAMINATION.

A candidate for being eligible for the Fourth Year Architecture Examination:-

- a) must have passed the Third Year Architecture Examination.
- b) must have kept satisfactory attendance for two academic terms of the Fourth Year.
- c) must have obtained minimum Sessional marks for passing all internal subjects heads for passing the Fourth Year Examination.

O.5014:-ELIGIBILITY CRITERIA FOR ADMISSION TO FIFTH YEAR ARCHITECTURE.

A candidate for being eligible for admission to the Fifth Year of Architecture:-

...4:-

- a) must have passed the Third Year Architecture Examination.
- b) must have kept satisfactory attendance for two academic terms of the Fourth Year.
- c) must have obtained minimum Sessional marks to clear all internal subjects heads for passing for the Fourth Year Examination.

O.5015:- ELIGIBILITY CRITERIA FOR FIFTH YEAR ARCHITECTURE EXAMINATION.

(Term I and Term II)

A candidate for being eligible for Term I of the Fifth Year Architecture Examination:-

- a) must have passed the Third Year Architecture Examination.
- must have obtained minimum Sessional marks for passing in all internal subjects heads of the Term I Examination of the Fifth Year.

A candidate for being eligible for Term II of the Fifth Year Architecture Examination:-

- a) must have passed the Fourth Year Architecture Examination.
- b) must have completed Professional Practice Internship of Term II of minimum 16 weeks.

Further that the amended Ordinances 5006, 5007, 5008, 5009, 5010, 5012, 5013, 5014 and 5015 relating to the First Year, Second Year, Third Year, Fourth Year and Fifth Year B.Arch. degree examinations will be brought into force with effect from the academic year 2005-2006
