CIRCULAR:-

A reference is invited to the Ordinances, Regulations and Syllabi and this office Circular No. UG/386 of 2005, dated 19th September, 2005 relating to the Bachelor of Physical Education (B.P.Ed.) degree course and the Principals of affiliated colleges in Physical Education are hereby informed that the recommendation made by the joint meeting of the Board of Studies in Education and Ad-hoc Board of Studies in Physical Education at its meeting held on 21st July, 2006 has been accepted by the Academic Council at its meeting held on 18th August, 2006 vide Item No.4:10 and subsequently approved by the Management Council at its meeting held on 15th September, 2006 vide Item No.13 and that in accordance therewith the **Regulation 5106** relating to the B.P.Ed. Course is amended to read as under :-

R.5106 :- For the purpose of Co-Ordination of Internal Assessment in Part B there shall be a Co-Ordination Committee consisting of :-

- i) Chairperson, **Ad-hoc Board of Studies in Physical Education**
- ii) Chairperson, B.P.Ed. Examination of the concerned year
- iii) One of the Principal of the Institution where the B.P.Ed. course is located as recommended by the **Ad-hoc Board of Studies in Physical Education**, University of Mumbai.

The Committee shall go through internal assessment marks and the grades awarded to students of different colleges of Physical Education. If any discrepancy is found in the standard of marking and/or of grading by college from the norms framed by the **Ad-hoc Board of Studies in Physical Education** the Principal concerned would be required to accordingly modify the marks as per the directions given by the co-ordination committee. The committee is authorized to check all the Internal work of the students of the colleges to verify the marks awarded by the college and make necessary changes wherever required.

Further that the amended **Regulation 5106** relating to the B.P.Ed. Course has been brought into force with effect from the academic year 2006-2007.
