(Computer Science) degree course to be introduced from the academic year 2007-2008 has been accepted by the Academic Council at its meeting held on 12th June, 2007 vide item No.4.16 and subsequently approved by the Management Council at its meeting held on 15th June, 2007 vide item No.17 and that in accordance therewith Ordinance 5719 relating to the B.Sc. (Computer Science) degree course has been passed to read as under:-

"O.5719: A candidate for being eligible for admission to the Three year integrated course leading to the degree of Bachelor of Science (B.Sc.) must have passed Higher Secondary School Certificate examination (Std.XII) in Science Stream conducted by the Maharashtra State Board of Secondary and Higher Secondary Education with Mathematics and Statistics as one of subject or it's equivalent.

Admission will be on merit, based on order of preference as follows:

Aggregate Marks at H.S.C. or equivalent.

2. Aggregate Marks in Science Group (Physics, Chemistry and Mathematics)

3. Marks in Mathematics and Statistics and Physics.

4. Marks in Mathematics and Statistics.

Intake Capacity 24/48

However, if the repeaters are admitted in S.Y.B.Sc. or in T.Y.B.Sc. (Computer Science) in addition to regular students of the same college, a new batch to be started if the strength exceeds 12 students more than the original sanctioned strength of 24/48 students subject to permission of University and Government."
