**Pattern of Question Paper
at the
Bachelor of Social Work
in Part III Examination**

(With effect from First Half of the year 2007)

Scheme of Question Papers: BSW III

The Annual/University examination will cover the entire syllabus prescribed for the respective papers.

The Annual/University examination will be of **two hours duration** for the papers of the total of 50 marks and **three hours duration** for papers of 100 marks. The Annual/University examination will be out of 30 marks for papers of 50 marks (20 marks being internal assessment) and 60 marks for papers of 100 marks (40 marks being internal assessment).

The total number of questions for each paper carrying a total of 50 marks shall be six. The first question will be compulsory and allotted 9 marks. Of the remaining five questions, which will carry 7 marks each, the students shall answer any three questions. Each paper will contain a minimum of one question out of the remaining five, which will be short notes and it may have internal choice.

The total number of questions for each paper carrying a total of 100 marks shall be eight, out of which the students shall attempt five questions carrying equal marks. Each paper will contain a minimum of one question, which will be short notes, and it may have internal choice.
