विषय: UG NEP प्रथम सत्र (उन्हाळी 2025) (Semester I - KT) व द्वितीय सत्र (Semester II - Regular) निकाला संबधित कार्यवाही करण्याबाबत सूचना.

विद्यापीठाशी संलग्नित /संचलित कला, वाणिज्य व विज्ञान महाविद्यालयांचे प्राचार्य/संचालक यांना, कळविण्यात येते की, प्रथम सत्रातील (Semester I - KT) व द्वितीय सत्रातील (Semester II - Regular) परीक्षांचे निकाल जाहीर करण्याची कार्यवाही सुरु आहे. त्यास अनुसरून पुढीलप्रमाणे कार्यवाही करण्यात यावी:

- 1. संबंधित सत्रांतील निकालाचे गुण महाविद्यालयांनी सर्व विद्यार्थ्यांसाठी (Notice Board/College Website इत्यादीद्वारे) (Programwise seat no wise) नुसार प्रदर्शित करावेत.
- 2. ज्या विद्यार्थ्यांना Semester I KT व Semester II Regular पुनर्मूल्यमापनासाठी (Revaluation) अर्ज करावयाचे असतील, अशा विद्यार्थ्यांकडून अर्ज निर्धारित वेळेत स्वीकारून. पुनर्मूल्यमापनाचे अंतिम गुण मंगळवार दिनांक १७ जुन, २०२७ पर्यंत **ई-समर्थ पोर्टलवर** महाविद्यालयांनी प्रविष्ट करावेत.
- 3. 10 गुणांपर्यंतच्या ग्रेससाठी पात्र विद्यार्थ्यांची यादी (Grace Marks under Ordinance 229) महाविद्यालयांनी DICT- CCF विभागाकडून देण्यात येणाऱ्या लिंकच्या माध्यमातून ऑनलाइन स्वरूपात सादर करावी.
- 4. जे विद्यार्थी उत्तीर्ण झालेले आहेत, अशा विद्यार्थ्यांची द्वितीय वर्षासाठी तात्पुरती प्रवेश (Provisional admission) प्रक्रिया व ज्या विद्यार्थांना एका महाविद्यालयातून दुसऱ्या महाविद्यालयात प्रवेश घ्यावयाचा (Transfer Case) असेल अशा विद्यार्थाची प्रवेश प्रकिया सुरू करण्यात यावी. CARRYFORWARD OF MARKS IN CASE OF A LEARNER WHO FAILS IN THE INTERNAL ASSESSMENT AND/OR SEMESTER-END ASSESSMENT IN ONE OR MORE SUBJECTS:

#### R-1

- A learner who PASSES in the Internal Examination but FAILS in the Semester End
  Examination of the course shall reappear for the Semester End Examination of that
  course. However, his/her marks on the Internal Examinations shall be carried over
  and he/she shall be entitled to the grade obtained by him/her on passing.
- 2. A learner who PASSES in the Semester End Examination but FAILS in the Internal Assessment of the course shall reappear for the Internal Examination of that course. However, his/her marks of the Semester End Examination shall be carried over and he/she shall be entitled for the grade obtained by him/her on passing.

# RULES FOR PROGRESSION (ALLOWED TO KEEP TERMS - ATKT):

## R-2

## For UG programmes:

- 1. A learner shall be allowed to keep term for Semester II irrespective of the number of courses of failure in Semester I.
- A learner shall be allowed to keep term for Semester III if he/she earns 32 or more Cumulative credits from Semester I & Semester II.
- 3. A learner shall be allowed to keep term for Semester IV irrespective of the number of courses of failure in Semester III.
- 4. A learner shall be allowed to keep term for Semester-V if he/she earns 76 or more Cumulative credits from Semester-I, II, III & IV.
- 5. A learner shall be allowed to keep the term for Semester VI irrespective of the Number of courses of failure in Semester V.
- 6. The result of Semester VI shall be withheld by the College till the learner passes all the Semesters from Semesters I to Semesters V.
- A Learner is allowed to take admission in semester VII (UG Hon. /PG Part I)
  only if he passed all courses of semesters I to VI (132 Credits).
