R.113: In order to qualify for the Certificate course in German, a candidate must obtain 50% of the full marks in the written and oral examination, separately.

Further that the amended Regulation 113 relating to the standard of passing for Certificate Course in German has been brought into force with effect from the academic year 2006-2007
