CIRCULAR :

Attention of the Head, University Department of Philosophy and the Principals of the affiliated colleges in Arts is hereby invited to this office Circulars No.193 of 1998, No.UG/99 of 1998, No.UG/498 of 1999 and No. UG/ 227 of 2001 dated 2nd June, 1998, 31st March, 1998, 6th October, 1999 and 5th July, 2001 and they are hereby informed that the recommendations made by the Board of Studies in Logic and Philosophy at its meeting held on 23rd September, and 7th October, 2004 have been accepted by the Academic Council at its meeting held on 14th December, 2004 vide item No. 4.30 and subsequently approved by the Management Council at its meeting held on 21st December, 2004 vide item No. 13 and that in accordance therewith the Regulations 3789, 3860, 3991, 4011 and 4177 relating to the Standard of passing for the Certificate Course in Jainology, Diploma Course in Yoga, Certificate Course in Yoga, Diploma Course in Jainology and Diploma Course in Buddhist and Vipassana, have been amended to read as under :-

Certificate Course in Jainology

R.3789 There will be a written examination carrying 200 marks (100 marks each and Project work of 50 marks. In the written examination, in each paper 40% marks will be assigned to the internal assessment and 60% to the year end examination. 40% marks will be required for passing separately in each paper as well as in the project work.

Diploma Course in Yoga

R.3860 There will be a written examination of 100 marks and practical examination of 100 marks. 40% marks will be required for passing separately in written and practical examination.

Certificate Course in Yoga

R.3991. There will be a written examination of 100 marks and practical examination of 100 marks. 40% marks will be required for passing separately in written and practical examination.

Diploma Course in Jainology

R.4011. There will be a written examination carrying 200 marks (2 papers of 100 marks each) and project work carrying 50 marks. In the written examination in each paper 40% marks will be required for passing separately in written and the project work. If the candidate does not submit the project work He/she will be declared as failed.

Diploma course in Buddhist and Vipassana

R.4177. There will be a written examination of 200 marks (2 papers of 100 marks each). 40% marks will be required for passing separately in each paper of 100 marks.

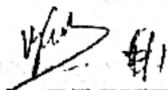
