

PRCULAR:

A reference is invited to the Ordinance, Regulation and Syllabi glating to the degree of Master of Physiotherapy (M.P.Th.) vide Pamphlet 130 and to this office Circular No.UG/439 of 2003, dated 11th september, 2003 and Deans of the affiliated Medical colleges and the pirector, All India Institute of Physical Medicine and Reliabilitation are hereby informed that the recommendation made by the Ad-hoc Committee appointed by the Academic Council to advise it on all matters relating to the ourses of study and examination relating to the degree of Master of physiotherapy (M.P.Th.) at its meeting held on 30th March 2005 has been greepted by the Academic Council at its meeting held on 2nd April, 2005 ride item 4.41 and subsequently approved by the Management Council at its meeting held on 16th April, 2005 vide item No.11 and that in accordance herewith Regulation 4373 relating to the scheme of examination for the Master of Physiotherapy (M.P.Th.) degree examination has been amended to read as under:-

R4373: The candidate will be examined in the following subjects-Written

Each paper will be of three hours duration. Papers I,II & III shall include three compulsory questions, whereas Paper IV shall include two compulsory essays. Each question shall carry 6 points.

Papers I & II shall be General papers common to all the students

Paper-I- Question 1: based on Allied sciences

Question 2: based on General conditions Question 3: based on Geriatric conditions

Paper-II-Question-1 based on applied sciences Question-2 on Physiotherapy in Child care Question-3 on Physiotherapy in Women's health

Papers III & IV shall be papers based on respective speciality Subject

Paper III - Question 1 on relevant applied sciences Question 2 based on Evaluation procedures Question 3 based on advanced trends in managements

Paper-IV- Two Essays

CLINICAL/PRACTICAL (Including viva-voce)

It will include Three case presentations based on Geriatric care, women;s health & Child care respectively + Two case presentation based on speciality subject + Spots + Microteaching presentation + Dissertation Mesentation Viva.

Each item-i.e. each case presentation. Spots; Microteaching & Viva shall carry maximum 6 points.

Further that the amended Regulation 4373 relating to the scheme of examination for the Master of Physiotherapy (M.P.TH.) degree course will be brought into force with effect from the academic year 2005-2006.
