Project Report

100 marks

The topic of the Project Report shall be submitted alongwith a synopsis in triplicate not exceeding 1000 words, for approval by the Departmental Committee comprising of following members :

- (1) Chairman – Ad-hoc Board of Studies in Library and Information Science
- (2) Head – Department of Library and Information Science, University of Mumbai.
- (3) Adjunct/visiting faculty member.

Each student shall work under the guidance of a recognized University teacher for his/her Project Report and shall submit two copies of the same to the Department of Library and Information Science, University of Mumbai at least two MONTHS prior to the date of commencement of the theory examination. The same will be assessed and evaluated by the examiners comprising of one Internal and one External Examiner appointed from amongst the panel of examiners.
