A reference is invited to the Regulations relating to the LL.B. degree course (Three Year and Five Year Degree Course) vide Pamphlet No. 44 and to this office Circular No. UG/516 of 2004 dated 24th November, 2004 and the Head, University Department of Law and the Principals of the affiliated colleges in Law are hereby informed that the recommendation made by the faculty of Law and the Board of Studies in Law at its joint meeting held on 12th January 2005 has been accepted by the Academic Council at its meeting held on 5th February, 2005 vide item No.4.10 and subsequently approved by the Management Council at its meeting held on 18th February, 2005 vide item No. 6 and that in accordance therewith the Regulation 4437 relating to the standard of passing for the LL.B. degree course (Three-Year and Five-Year) is amended to read as under:-

R.4437: To pass the examination the candidates must obtain 45% marks in each paper/s and practical/s separately. Those candidates who obtain less than 60% of the marks in all paper/s at one and the same sitting will be placed in the Second Class. Those of the successful candidates who obtain 60% marks and more than 60% marks in all paper/s at one and the same sitting will be placed in the First Class.

A candidate who obtains 45% marks in Theory paper/s and practical/s may, at his option, be exempted from appearing in the paper/s and practical/s, as the case may be.

Further that the amended Regulation 4437 has been brought into force with effect from the examination held in the second half of the year 2004.
