"It was thereupon **resolved** that the examinations of the Fourth Year (Five Year) and First Year (Three year) degree courses which were transferred to the respective colleges in Law to be conducted by them on behalf of University with common time-table and common questions- papers provided by the University with effect from the examinations to be held from the Second half of 2004, and communicated to the colleges (vide Circular No.UG.27 dated 3rd January, 2004) be now conducted by the University and not by the respective Law Colleges."
