Attention of the Head, University Department of Mathematics, Principals of the affiliated colleges in the faculty of Arts and Science, the Heads of the Recognized Institutions concerned and the Director, Institute of Distance Education is hereby invited to the Ordinances, Regulations and syllabi relating to the M.A. M.Sc. degree course vide pamphlet No.157 and 175 and to this office Circular No.UG-563 of 2003 dated 10th December, 2003 and they are hereby informed that the recommendation made by the Board of Studies in Mathematics at its meeting held on 12th February, 2004 has been approved by the Vice-Chancellor in exercise of the powers conferred upon him under Section 14(7) of the Maharashtra Universities Act 1994. the following corrections have been incorporated in the Circular No.UG/565 dated 10th December, 2003 :

a) M.A. M.Sc. Mathematics Part -I

Clause (ii) should be amended to read as under :-

"(ii) Institute of Science students also be continued under the same scheme in force as before."

and

Clause (iii) should be amended to read as under :-

"(iii) Lokmanya Tilak Post-graduate centre should adopt the scheme of 60% internal and 40% external" from the academic year 2003-2004."

b) M.A. M.Sc. Mathematics Part-II

Clause (ii) should be amended to read as under :-

"(ii) The other two centres should follow their respective schemes as before"
