

Paper THE: Canadian and Australian Literatures

Background - Themes and Issues:

a) General Background to Canadian and Australian Literatures

- Differences in the colonial experience between settler colonies like Canada, Australia and New Zealand on the one hand and conquered countries in Asia and Africa on the other.
- Differences in the colonial experience among the three main settler colonies.

b) Background to Canadian Literature :

- The response of the early European writers to the vastly different landscape and climate. The gradual displacement of the two colonial myths (which see Nature either as a nurturer or "a blue-eyed bitch") and the evolution of the postcolonial myth which sees Nature as a process, embodying opposites.
- The response of the early settlers in both Anglophone and Francophone Canada to received literary traditions.
- Pre-Confederation Literature
- Canadian small town novels of the early twentieth century, reflecting what Frye calls 'the garrison mentality'
- The 'French Problem' after the French handed over French Canada to the English the separatist versus federalist debate the Quiet Revolution in the sixties Bill 101 and the language problem
- The impact of Jansenistic Catholicism on the French-Canadians and Calvanist Protestantism on the English-Canadians as reflected in literature.
- The growing desire among the nationalists in the 70s to define the Canadian identity as distinct from the English, French and American identities.
- The emergence of First Nations voices in Canadian literature to challenge the coloniser's appropriation and misrepresentation of their reality.
- The critique of gender inequality in the literature by Canadian women
- The double-visioned discourse of ethnic minorities which lays bare the ethnocentrism that lurks under the multicultural myth embraced by Canada. The growing realisation that writing is a legitimate way of participating in struggle. And that social iniquities must be addressed to make Canada their home.

Background to Australian Literature:

- The response of the early Australian settlers to received literary traditions.
- The response of early writers to the vastly different landscape and climate "Antipodean (climatic) inversion", unfamiliar, unfathomable ad even hostile landscape with regular droughts, floods and bushfires.
- Early settler colony writing (1851-1914) in Australia.
- Growth of Nationalist Literature and the construction of the 'Australian' identity. The Gold Rushes and growth of melodrama between 1860s-1890s and the development of short fiction with Henry Lawson.
- Imaging a nation in the midst of fin-de-siecle anxieties, growing doubts about the greatness of the Empire.
- The World Wars and the impact of Nazism. The development of the novel, particularly social realist fiction, 'bush-centred' nationalism and women's writing.
 - The creation of 'manhood' myths in the inter-war years
- Images of the Aborigines in Australian literature
- Industrialization, the growth of mass cultural forms and Australia's separation from England.

- Post-war literature in Australia as characterised by simple, direct, linear narratives which plainly express nostalgia and sorrow and reflect a conservative use of language and literary traditions.
- Institutionalization of Australian Literature in the 1960s. The shift in focus to the immigrant experience in Australia often reflected in the growing complexity of the novel form.
- Post-Vietnam Australian sensibility.
- The representation of the indigenous and ethnic experience in recent Australian literature which is dominated by the themes of alienation, cultural loss, dislocation, biculturalism, poverty, inequality, host society prejudice, intergenerational conflict, nostalgia. Amidst different "Australias", the Australian national identity seems to be on shifting grounds.
- Post-70s writing reflects boid experimentations with Eurocentric literary forms and language. It often questions the biases encoded in the coloniser's language and valourises the potency of Australian English. It also articulates protest against social inequalities and problematises the constructions of the colonisers. The creative strategies used by writers include a conscious foregrounding of oral literature and paraliterary forms like diaries and autobiographies, a subversion of western models through humour satire, irony; sophistry, cunning and trickery and the creation of new cultural spaces for themselves by laying bare "the inexorable plot of racism" (Cixous).




