Attention of the Principals of the affiliated colleges in Commerce and Professor-cum-Director, Institute of Distance Education is hereby invited this office Circular No.UG/384 of 2005 dated 19<sup>th</sup> September,2005 and they are hereby informed that the recommendation made by the Board of Studies in Commerce at its meeting held on 7<sup>th</sup> February,2006 has been accepted by the Academic Council at its meeting held on 10<sup>th</sup> February 2006 vide Item No.4.17 and subsequently approved by the Management Council at its meeting held on 18<sup>th</sup> February,2006 vide item No.3 and that in accordance therewith Regulation 4301 relating to the M.Com.(E-Commerce) degree course is amended to read as under:-

## R.4301 :- Performance Grading -

(a) The performance grading of the student shall be of the seven point ranking system as under:-

Point	Marks	Grade
I	80 and above	0
II	70-80	A+
III	60-69	A
IV	55-59	B+
V	50-54	В
VI	40-49	C
VII	0-39	F

Average will be rounded off in the usual way whilst granting grade.

The performance grading shall be based on the aggregate performance of internal assessment and semester end examination.

- (b) The performance grading shall be based on the aggregate performance of internal assessment and external assessment. A student must secure a minimum of 40% marks in aggregate i.e. minimum of 40% in internal assessment as well as 40% marks in external assessment separately, in order to pass the examination including the training report and the project report marks at the III/IV semester.
- (c) A student is not eligible to secure consolidated grade for the semester if he/she gets F grade either in internal or external assessment in any one subject in that semester.
- (d) The student is required to have a grade for each semester separately.
- (e) Carry forward of Internal marks: A candidate who fails in any particular paper shall be allowed to reappear for that theory paper/s. However, his /her internal assessment marks shall be carried forward.

Further that the amended Regulations 4301 is brought into force with effect from the examination held in the second half of 2005.
