

CIRCULAR :-

A reference is invited to the Ordinances, Regulations relating to the M.E. degree course examination vide this office Circular No.UG/263 of 2005, dated 4th July, 2005 and the Principals of the affiliated colleges in Engineering are hereby informed that the recommendation made by the Faculty of Technology at its meeting held on 9th January, 2007 has been accepted by the Academic Council at its meeting held on 9th February, 2007 vide Item No.4.44 and subsequently approved by the Management Council at its meeting held on 14th February, 2007 vide Item No.27 and accordance therewith Regulation 4156 relating to the M.E. degree examination is amended to read as under :-

R.4156 : In order to be eligible for First/Second Class, a candidate must appear and pass the First and Second Semester examinations in not more than four consecutive Semesters after registration. Further that the candidate shall submit the dissertation on or before 31st August of the fourth academic year from the date of registration.

Further that the amended Regulation 4156 relating to the M.E. degree examination has been brought into force with retrospective effect from the academic year 2003-2004.
