A reference is invited to the Ordinances, Regulations and syllabi relating to the M.E. degree examination vide Pamphlet No.190 and to this office Circular No.UG/90 of 2007, dated 13th March, 2007 and the Principals of the affiliated colleges in Engineering are hereby informed that the recommendation made by the Faculty of Technology at its meeting held on 26th March, 2008 has been accepted by the Academic Council at its meeting held on 15th April, 2008 vide item No 4.50 and subsequently approved by the Management Council at its meeting held on 24th April, 2008 vide item No.16 and that, in accordance therewith, the Ordinance 5134 relating to the Eligibility Criteria for admission to the M.E. degree course has been amended by incorporating "Chemical Engineering" branch under Serial No.11 and O.5134 thus amended to read as under:-

O.5134: Any person who has passed any examination for the degree of Bachelor of Engineering of this University or the degree of Bachelor of Engineering of any other University recognized as equivalent to the Bachelor of Engineering degree of this University be deemed eligible for admission to the Master's degree course in Engineering in the specific branch in which he has taken degree of Bachelor of Engineering of a related branch as listed below:

Further that in exercise of the powers conferred upon the Management Council under Section 54(1) of the Maharashtra Universities Act, 1994 it has amended Ordinance 5134 relating to the eligibility criteria for admission to the M.E. degree course and the same has been brought into force with effect from the academic year 2008-2009.
