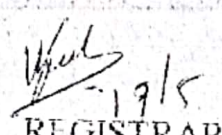
Attention of Principals of the affiliated colleges in Engineering is hereby invited to the Regulation to Master of Engineering (M.E.)(Full-time and Part-time) vide Pamphlet No.190 and they are hereby informed that the recommendation made by the Faculty of Technology at its meeting held on 15th March, 2005 has been accepted by the Academic Council at its meeting held on 2nd April, 2005 vide item No.4.18 and subsequently approved by the Management Council at its meeting held on 16th April, 2005 vide item No.11 and that in accordance therewith the Regulation 4895 for class improvement relating to the M.E.(Full-time and Part-time) degree course has been passed as under :-

R.4895: candidates who have passed the Master of Engineering (Full-time) degree examination of this University and who wish to improve their class be permitted to appear again for the same examination with the same subjects (all subjects of Semester I together and all subjects of Semester II together) without being required to keep any term again. This provision shall be applicable subsequent to the first passing of degree examination for not more than three consecutive examinations conducted by the University. Marks obtained by the candidates in term-work, internal assessment of Semesters I and II and marks obtained in Semesters III and IV shall be carried forward for not more than the three consecutive examinations.

Candidates who have passed the Master of Engineering (Part-time) degree examination of this University and who wish to improve their class be permitted to appear again for the same examination with the same subjects (all subjects of Semester I and II together, all subjects of Semesters III and IV together and all subjects of Semester V together) without being required to keep any term again. This provision shall be applicable subsequent to the first passing of the Degree examination for not more than four consecutive examinations conducted by University. Marks obtained by the candidates in term-work, internal assessment of Semester I to Semester V and marks obtained in Semesters VI & VII shall be carried forward for not more than four consecutive examinations.

Further that the above Regulation 4895 will be brought into force with effect from the examination to be held in the Second half of 2005.

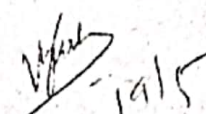
