Attention of the Director, Jamnalal Bajaj Institute of Management Studies and the Directors of the recognized Management Institutes is hereby invited to the provision of the admission criteria for M.M.S. degree course/Ordinance relating to the admission for the Master of Management Studies (M.M.S.) degree course vide pamphlet No. 126 and to this office Circular No. UG/385 of 2004 dated 3rd September, 2004 and they are hereby informed that the recommendation made by the Ad-hoc Board of Studies in Management Courses (Under-Graduate and Post Graduate) at its meeting held on 27th August, 2004 has been accepted by the Academic Council at its meeting held on 8th October, 2004 vide item No.4.3 and subsequently approved by the Management Council at its meeting held on 29th October, 2004 vide item No.22 and that in accordance therewith, the O.2068 relating to the eligibility criteria prescribed for admission to the M.M.S. degree course has amended to read as under :-

<u>Q.2068</u>: A candidate for being eligible for admission to the degree of Master of Management Studies (MMS) must have passed on or before 31st July, Bachelor's degree of minimum 3 years duration in any discipline recognized by Association of Indian Universities, New Delhi, with minimum 45% marks in aggregate and 40% in case of backward class candidates from Maharashtra State only.

#### AND

Must have passed Common Entrance Test which will be conducted by the Competent Authorities designated by the State Government as the sole authority calling for applications and effecting admissions through the Common Entrance Test.

Furhter that the amended O.2068 has been brought into force with effect from the academic year 2004-2005.
